Dear Mr. Goodman and Ms. Baker:

Pursuant to RCW 43.15.050, the Office of Lieutenant Governor hereby submits the FY2010 Legislative International Trade Account (LITA) report to the Legislature. We regret the tardiness of the report which was the responsibility of a former staffer. When we discovered the report had not yet been filed we made every effort to rectify the situation.

Established by the legislature in 2003, LITA allows funds to be received by the President of the Senate and Secretary of State for international trade hosting, international relations and international missions, to be deposited into the account. Expenditures from the account may only be used for these purposes, excluding lodging and travel, in which the president and members of the senate, members of the house of representatives, and the secretary of state participate in an official capacity. All requests for use of funds from this account by individual legislators, the lieutenant governor or secretary of state must be jointly approved by the chief clerk of the house of representatives, the secretary of the senate, and the president of the senate.

For FY2010 total contributions to the LITA account were \$0, while expenditures totaled \$1022.01. The balance of the account on the first day of the fiscal year, July 1, 2009, was \$7487.42. The balance at the close of the fiscal year on June 30, 2010 was \$6,465.41.
