## Executive Summary

A proviso is a line item in the budget that provides funding for a specific purpose, often placing limitations on how that funding can be used. Education provisos have been appropriated for many years and give funding to a variety of programs, such as the education of students experiencing homelessness and youth suicide prevention.

As more provisos are funded, both efficiency and transparency become challenging. In 2017, a total of 114 education provisos were in effect. The 2018 Supplemental Operating Budget, Engrossed Substitute Senate Bill (ESSB) 6032, gives the Office of Superintendent of Public Instruction (OSPI) the opportunity to “develop recommendations to amend long-standing provisos within Part V of the omnibus operating budget.”

OSPI’s proposals fall into three broad categories: combining, revising, and moving provisos. Broadly speaking, the revisions will simplify the budget-writing process by reducing the number of program budgets and by creating separate program budgets for the State Board of Education (SBE), the Professional Educator Standards Board (PESB), and the Financial Education Public-Private Partnership (FEPPP).

OSPI also proposes creating a new program budget that contains all of the provisos that serve to pass through funds to other agencies and organizations.

## Introduction

Section 501(64) of the 2018 Supplemental Operating Budget provides the Office of Superintendent of Public Instruction an opportunity to “develop recommendations to amend long-standing provisos within Part V of the omnibus operating budget.”

OSPI’s proposals broadly fall into three categories: combining, revising, and moving provisos. Two examples illustrate the approach:

1. A single proviso would combine three existing provisos that provide funds to support children’s mental health and suicide prevention.
2. Language should be updated to more closely align to the way the work is currently done. Section 507 of the Supplemental Budget provides funding for special education services. Language in that section should describe “students who receive special education services” instead of “special education students.”

The table below summarizes OSPI’s recommendations regarding both the structure of the budget and revisions to selected provisos.

(3) Combine performance-based evaluation proviso with (12) BEST proviso and (16) teacher principal evaluation proviso.	(6) Revise to include references to P-5 literacy support.
