1 AN ACT Relating to charitable solicitations; amending RCW
2 19.09.020, 19.09.065, 19.09.075, 19.09.079, 19.09.085, 19.09.097,
3 19.09.271, 19.09.100, 19.09.190, 19.09.200, 19.09.210, 19.09.230,
4 19.09.240, 19.09.275, 19.09.305, and 19.09.315; adding new sections to
5 chapter 19.09 RCW; creating new sections; repealing RCW 19.09.078;
6 prescribing penalties; providing an effective date; and declaring an
7 emergency.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

9 **Sec. 1.** RCW 19.09.020 and 1986 c 230 s 2 are each amended to read
10 as follows:

11 When used in this chapter, unless the context otherwise requires:

12 (1) A "bona fide officer or employee" of a charitable organization
13 is one (a) whose conduct is subject to direct control by such
14 organization; (b) who does not act in the manner of an independent
15 contractor in his or her relation with the organization; and (c) whose
16 compensation is not computed on funds raised or to be raised.

17 (2) "Charitable organization" means any entity that solicits or
18 collects contributions from the general public where the contribution

1 is or is purported to be used to support a charitable activity, but
2 does not include any commercial fund raiser or commercial fund-raising
3 entity as defined in this section. "Charitable" (a) is not limited to
4 its common law meaning unless the context clearly requires a narrower
5 meaning; (b) does not include religious or political activities; and
6 (c) includes, but is not limited to, educational, recreational, social,
7 patriotic, legal defense, benevolent, ~~((or))~~ and health causes;
8 however, a bona fide institution of higher education located in the
9 state of Washington, whether public or private, or a separate
10 foundation whose purpose is to raise funds solely for such an
11 institution, is not a charitable organization.

12 (3) "Compensation" means salaries, wages, fees, commissions, or any
13 other remuneration or valuable consideration.

14 (4) "Contribution" means the payment, donation, promise or grant,
15 for consideration or otherwise, of any money or property of any kind or
16 value which contribution is wholly or partly induced by a solicitation.
17 Reference to dollar amounts of "contributions" or "solicitations" in
18 this chapter means in the case of payments or promises to pay for
19 merchandise or rights of any description, the value of the total amount
20 paid or promised to be paid for such merchandise or rights less the
21 reasonable purchase price to the charitable organization of any such
22 tangible merchandise, rights, or services resold by the organization,
23 and not merely that portion of the purchase price to be applied to a
24 charitable purpose.

25 (5) "Cost of solicitation" means and includes all direct and
26 indirect costs, expenditures, debts, obligations, salaries, wages,
27 commissions, fees, or other money or thing of value paid or incurred in
28 making a solicitation. Cost of solicitation does not include the
29 reasonable purchase price to the charitable organization of any
30 tangible goods or services resold by the organization as a part of its
31 fund raising activities.

32 (6) "Entity" means an individual, organization, group, association,
33 partnership, corporation, agency or unit of state government, or any
34 combination thereof.

35 (7) "General public" or "public" means any individual located in
36 Washington state without a membership or other official relationship
37 with a charitable organization before a solicitation by the charitable
38 organization.

1 (8) "~~((Independent))~~ Commercial fund raiser" or "~~((independent))~~
2 commercial fund-raising entity" means any entity that for compensation
3 or other consideration, plans, conducts, manages, or administers any
4 drive or campaign in this state for the purpose of soliciting
5 contributions for or on behalf of any charitable organization or
6 charitable or religious purpose, or that is engaged in the business of
7 or is held out to persons in this state as independently engaged in the
8 business of soliciting contributions for such purposes, or the business
9 of planning, conducting, managing, or carrying on any drive or campaign
10 in this state for such solicitations. However, a ~~((nonprofit fund~~
11 ~~raiser or))~~ bona fide officer or other employee of a charitable
12 organization shall not be deemed ~~((an independent))~~ a commercial fund
13 raiser.

14 (9) "Membership" means that for the payment of fees, dues,
15 assessments, etc., an organization provides services and confers a bona
16 fide right, privilege, professional standing, honor, or other direct
17 benefit, in addition to the right to vote, elect officers, or hold
18 office. The term "membership" does not include those persons who are
19 granted a membership upon making a contribution as the result of
20 solicitation.

21 ~~((10))~~ ~~("Nonprofit fund raiser" means an entity registered as a~~
22 ~~nonprofit corporation under Title 24 RCW, or any entity exempt from~~
23 ~~federal income tax under section 501(c) of the Internal Revenue Code,~~
24 ~~that solicits and receives contributions exceeding five thousand~~
25 ~~dollars in any accounting year on behalf of a charitable or religious~~
26 ~~organization other than the nonprofit corporation.~~

27 ~~((11))~~ "Other employee" of a charitable organization means any
28 person (a) whose conduct is subject to direct control by such
29 organization; (b) who does not act in the manner of any independent
30 contractor in his or her relation with the organization; and (c) who is
31 not engaged in the business of or held out to persons in this state as
32 independently engaged in the business of soliciting contributions for
33 charitable or religious purposes.

34 ~~((12))~~ (11) "Parent organization" means that part of a charitable
35 organization that coordinates, supervises, or exercises control over
36 policy, fund raising, or expenditures, or assists or advises one or
37 more chapters, branches, or affiliates of such organization in the
38 state of Washington.

1 (~~(13)~~) (12) "Political activities" means those activities subject
2 to chapter 42.17 RCW or the Federal Elections Campaign Act of 1971, as
3 amended.

4 (~~(14)~~) (13) "Religious activities" means those religious,
5 evangelical, or missionary activities under the direction of a
6 religious organization duly organized and operating in good faith that
7 are entitled to receive a declaration of current tax exempt status for
8 religious purposes from the United States government and the duly
9 organized branches or chapters of those organizations.

10 (~~(15)~~) (14) "Secretary" means the secretary of state.

11 (~~(16)~~) (15) "Solicitation" means any oral or written request for
12 a contribution, including the solicitor's offer or attempt to sell any
13 property, rights, services, or other thing in connection with which:

14 (a) Any appeal is made for any charitable purpose; or

15 (b) The name of any charitable organization is used as an
16 inducement for consummating the sale; or

17 (c) Any statement is made that implies that the whole or any part
18 of the proceeds from the sale will be applied toward any charitable
19 purpose or donated to any charitable organization.

20 The solicitation shall be deemed completed when made, whether or
21 not the person making it receives any contribution or makes any sale.

22 Bingo activities, raffles, and amusement games conducted under
23 chapter 9.46 RCW and applicable rules of the Washington state gambling
24 commission are specifically excluded and shall not be deemed a
25 solicitation under this chapter.

26 **Sec. 2.** RCW 19.09.065 and 1986 c 230 s 3 are each amended to read
27 as follows:

28 (1) All charitable organizations(~~(, independent)~~) and commercial
29 fund raisers(~~(, and nonprofit fund raisers, as defined in RCW~~
30 ~~19.09.020,)~~) shall register with the secretary prior to conducting any
31 solicitations.

32 (2) Failure to register as required by this chapter is a violation
33 of this chapter.

34 (3) Information provided to the secretary pursuant to this chapter
35 shall be a public record except as otherwise stated in this chapter.

36 (4) Registration shall not be considered or be represented as an
37 endorsement by the secretary or the state of Washington.

1 **Sec. 3.** RCW 19.09.075 and 1986 c 230 s 4 are each amended to read
2 as follows:

3 An application for registration as a charitable organization shall
4 be submitted in the form prescribed by rule by the secretary,
5 containing, but not limited to, the following:

6 (1) The name, address, and telephone number of the charitable
7 organization;

8 (2) The name(s) under which the organization will solicit
9 contributions;

10 (3) The name, address, and telephone number of the officers of the
11 organization;

12 (4) The names of the three officers or employees receiving the
13 greatest amount of compensation from the organization;

14 (5) The purpose of the organization;

15 (6)(a) Whether the organization is exempt from federal income tax;
16 and if so the organization shall attach to its application a true copy
17 of the letter by which the internal revenue service granted such
18 status; and

19 (b) (~~Whether the financial affairs of the organization are audited~~
20 ~~by an independent entity and, if so,~~) The name and address of the
21 entity that prepares, reviews, or audits the financial statement of the
22 organization;

23 (7) A solicitation report of the organization for the preceding
24 accounting year including:

25 (a) The number and types of solicitations conducted;

26 (b) The total dollar value of support received from solicitations
27 and from all other sources received on behalf of the charitable purpose
28 of the charitable organization;

29 (c) The total amount of money applied to charitable purposes, fund
30 raising costs, and other expenses;

31 (d) The name, address, and telephone number of any (~~independent~~)
32 commercial fund raiser used by the organization; and

33 (8) An irrevocable appointment of the secretary to receive service
34 of process in noncriminal proceedings as provided in RCW 19.09.305.

35 The requirements of subsection (7) (b) and (c) of this section may
36 be satisfied by the submission of such federal tax forms as may be
37 approved by rule of the secretary.

38 The application shall be signed by the president, treasurer, or
39 comparable officer of the organization (~~and~~) whose signature shall be

1 notarized. The application shall be submitted with a nonrefundable~~((7~~
2 ~~ten-dollar))~~ filing fee in an amount to be established by the secretary
3 by rule. If the secretary determines that the application is complete,
4 the application shall be filed and the applicant deemed registered.

5 The secretary shall notify the director of veterans' affairs upon
6 receipt of an application for registration as a charitable organization
7 from an entity that purports to raise funds to benefit veterans of the
8 United States military services. The director of veterans' affairs may
9 advise the secretary and the attorney general of any information,
10 reports, or complaints regarding such an organization.

11 **Sec. 4.** RCW 19.09.079 and 1986 c 230 s 7 are each amended to read
12 as follows:

13 An application for registration as ~~((an independent))~~ a commercial
14 fund raiser shall be submitted in the form prescribed by the secretary,
15 containing, but not limited to, the following:

16 (1) The name, address, and telephone number of the ~~((independent))~~
17 commercial fund-raising entity;

18 (2) The name(s), address(es), and telephone number(s) of the
19 owner(s) and principal officer(s) of the ~~((independent))~~ commercial
20 fund-raising entity;

21 (3) The name, address, and telephone number of the individual
22 responsible for the activities of the ~~((independent))~~ commercial fund-
23 raising entity in Washington;

24 (4) A list of states and Canadian provinces in which fund raising
25 has been performed;

26 (5) The names of the three officers or employees receiving the
27 greatest amount of compensation from the ~~((independent))~~ commercial
28 fund-raising entity;

29 ~~((Whether the financial affairs of the independent fund raiser~~
30 ~~are audited by an independent entity, and, if so,))~~ The name and
31 address of the entity that prepares, reviews, or audits the financial
32 statement of the organization;

33 (7) A solicitation report of the ~~((independent))~~ commercial fund-
34 raising entity for the preceding accounting year, including:

35 (a) The number and types of fund raising services conducted;

36 (b) The names of charitable organizations required to register
37 under RCW 19.09.065 for whom fund raising services have been performed;

1 (c) The total value of contributions received on behalf of
2 charitable organizations required to register under RCW 19.09.065 by
3 the ~~((independent))~~ commercial fund raiser, affiliate of the
4 ~~((independent))~~ commercial fund raiser, or any entity retained by the
5 ~~((independent))~~ commercial fund raiser; and

6 (d) The amount of money disbursed to charitable organizations for
7 charitable purposes, net of fund raising costs paid by the charitable
8 organization as stipulated in any agreement between charitable
9 organizations and the ~~((independent))~~ commercial fund raiser;

10 (8) The name, address, and telephone number of any ~~((independent))~~
11 commercial fund raiser that was retained in the conduct of providing
12 fund raising services; and

13 (9) An irrevocable appointment of the secretary to receive service
14 of process in noncriminal proceedings as provided in RCW 19.09.305.

15 The application shall be signed by an officer or owner of the
16 ~~((independent))~~ commercial fund raiser and shall be submitted with a
17 nonrefundable(~~(, fifty dollar filing)~~) fee in an amount to be
18 established by rule of the secretary. If the secretary determines that
19 the application is complete, the application shall be filed and the
20 applicant deemed registered.

21 **Sec. 5.** RCW 19.09.085 and 1986 c 230 s 8 are each amended to read
22 as follows:

23 (1) Registration under this chapter shall cease to be effective
24 ~~((for))~~ after one year, or on the ~~((end of))~~ fifteenth day of the fifth
25 month after the organization's accounting year ends, whichever comes
26 first.

27 (2) Reregistration required under RCW 19.09.075 ~~((and 19.09.078))~~
28 shall be ~~((received by))~~ submitted to the secretary no later than the
29 fifteenth day of the fifth month after the organization's accounting
30 period ends.

31 (3) Reregistration required under RCW 19.09.079 shall be ~~((received~~
32 ~~by))~~ submitted to the secretary no later than the fifteenth day of the
33 third month after the organization's accounting period ends.

34 (4) Entities required to register under this chapter shall file a
35 notice of change of information within thirty days of any change in the
36 information contained in RCW 19.09.075 (1) through (6)~~((7))~~ or
37 19.09.079 (1) through (6)~~((7 or 19.09.078 (1) through (4)))~~.

1 (5) The secretary (~~may~~) shall notify entities registered under
2 this chapter of the need to reregister upon the expiration of their
3 current registration. The notification shall be by mail, sent at least
4 sixty days prior to the expiration of their current registration.
5 Failure to register shall not be excused by a failure of the secretary
6 to mail the notice or by an entity's failure to receive the notice.

7 **Sec. 6.** RCW 19.09.097 and 1986 c 230 s 10 are each amended to read
8 as follows:

9 (1) No charitable organization may contract with a commercial fund
10 raiser for any fund raising service or activity unless its contract
11 requires that both parties comply with the law and permits officers of
12 the charity reasonable access to: (a) The fund raisers' financial
13 records relating to that charitable organization; and (b) the fund
14 raisers' operations including without limitation the right to be
15 present during any telephone solicitation. In addition, the contract
16 shall specify the amount of raised funds that the charitable
17 organization will receive or the method of computing that amount, the
18 amount of compensation of the commercial fund raiser or the method of
19 computing that amount, and whether the compensation is fixed or
20 contingent.

21 (2) Before (~~contracting~~) a charitable organization may contract
22 with a commercial fund raiser for any fund raising service or activity,
23 the charitable organization and (~~independent~~) commercial fund raiser
24 shall complete a registration form. The registration shall be filed by
25 the charitable organization with the secretary, in the form prescribed
26 by the secretary, within five working days of the execution of the
27 contract containing, but not limited to the following information:

28 (~~1~~) (a) The name and registration number of the (~~independent~~)
29 commercial fund raiser;

30 (~~2~~) (b) The name of the surety or sureties issuing the bond
31 required by RCW 19.09.190, the aggregate amount of such bond or bonds,
32 the bond number(s), original effective date(s), and termination
33 date(s);

34 (~~3~~) (c) The name and registration number of the charitable
35 organization;

36 (~~4~~) (d) The name of the representative of the (~~independent~~)
37 commercial fund raiser who will be responsible for the conduct of the
38 fund raising;

1 ~~((5))~~ (e) The type(s) of service(s) to be provided by the
2 ~~((independent))~~ commercial fund raiser;

3 ~~((6))~~ (f) The dates such service(s) will begin and end;

4 ~~((7))~~ (g) The terms of the agreement between the charitable
5 organization and ~~((independent))~~ commercial fund raiser relating to:

6 ~~((a))~~ (i) Amount or percentages of amounts to inure to the
7 charitable organization;

8 ~~((b))~~ (ii) Limitations placed on the maximum amount to be raised
9 by the fund raiser, if the amount to inure to the charitable
10 organization is not stated as a percentage of the amount raised;

11 ~~((c))~~ (iii) Costs of fund raising that will be the responsibility
12 of the charitable organization, regardless of whether paid as a direct
13 expense, deducted from the amounts disbursed, or otherwise; and

14 ~~((d))~~ (iv) The manner in which contributions received directly by
15 the charitable organization, not the result of services provided by the
16 ~~((independent))~~ commercial fund raiser, will be identified and used in
17 computing the fee owed to the ~~((independent))~~ commercial fund raiser;

19 ~~((8))~~ (h) The names of any entity to which more than ten percent
20 of the total anticipated fund raising cost is to be paid, and whether
21 any principal officer or owner of the ~~((independent))~~ commercial fund
22 raiser or relative by blood or marriage thereof is an owner or officer
23 of any such entity.

24 (3) A true and correct copy of the contract must be filed with the
25 secretary before the commencement of any campaign.

26 (4) The registration form shall be submitted with a
27 nonrefundable(~~(, five dollar)~~) filing fee in an amount to be
28 established by rule of the secretary and shall be signed by an owner or
29 principal officer of the ~~((independent))~~ commercial fund raiser and the
30 president, treasurer, or comparable officer of the charitable
31 organization.

32 **Sec. 7.** RCW 19.09.271 and 1986 c 230 s 17 are each amended to read
33 as follows:

34 (1) Any charitable organization(~~(, nonprofit fund raiser,)~~) or
35 ~~((independent))~~ commercial fund raiser who, after notification by the
36 secretary, fails to properly register under this chapter by the end of
37 the first business day following the issuance of the notice, is liable
38 for a late filing fee (~~of five dollars per day from the date of the~~

1 notice until the registration is properly completed and filed)) in an
2 amount to be established by rule of the secretary. The late filing fee
3 is in addition to any other filing fee provided by this chapter.

4 (2) The secretary shall notify the attorney general of any entity
5 liable for late filing fees under subsection (1) of this section.

6 **Sec. 8.** RCW 19.09.100 and 1986 c 230 s 11 are each amended to read
7 as follows:

8 The following conditions apply to solicitations as defined by RCW
9 19.09.020:

12 ~~organization solicited:~~

13 (a) ~~The name of the individual making the solicitation;~~

14 (b) ~~The name of the charitable organization;~~

16 ~~organization that will receive the funds contributed; and~~

17 (d) ~~Whether the charitable organization is or is not properly~~
18 ~~registered under this chapter, and if registered, that information~~

32 (b) ~~If the solicitation is conducted by an independent or nonprofit~~
33 ~~fund raiser, the percentage relationship between (i) the amount of~~
34 ~~money disbursed to charitable organizations for charitable purposes;~~
35 ~~and (ii) the total value of contributions received on behalf of~~
36 ~~charitable organizations by the independent or nonprofit fund raiser,~~
37 ~~as contained in the fund raiser's most recent solicitation report filed~~
38 ~~in accordance with RCW 19.09.079(7) or 19.09.078.~~

1 ~~(3) Each person or organization soliciting charitable contributions~~
2 ~~by telephone shall make the disclosures required by RCW 19.09.100(2)~~
3 ~~(a) or (b) in writing within five days of the receipt of any~~
4 ~~contribution. If the person or organization sends any materials to the~~
5 ~~person or organization solicited before the receipt of any~~
6 ~~contribution, those materials shall include the disclosures required in~~
7 ~~RCW 19.09.100(1)(d), and 19.09.100 (2) (a) or (b), whichever is~~
8 ~~applicable.~~

9 (4)) A charitable organization, whether or not required to
10 register pursuant to this chapter, that directly solicits contributions
11 from the public in this state shall make the following clear and
12 conspicuous disclosures at the point of solicitation:

13 (a) The true name of the individual making the solicitation;

14 (b) The identity of the charitable organization and the city of the
15 principal place of business of the charitable organization;

16 (c) If requested by the solicitee, the toll-free number for the
17 donor to obtain additional financial disclosure information on file
18 with the secretary.

19 (2) A commercial fund raiser shall clearly and conspicuously
20 disclose at the point of solicitation: (a) The name of the individual
21 making the solicitation; (b) the name of the entity for which the fund
22 raiser is an agent or employee and the name and city of the charitable
23 organization for which the solicitation is being conducted; and (c) if
24 requested by the solicitee, the toll-free number for the donor to
25 obtain additional financial disclosure information on file with the
26 secretary. The disclosure must be made during an oral solicitation of
27 a contribution, and at the same time at which a written request for a
28 contribution is made.

29 (3) A person or organization soliciting charitable contributions by
30 telephone shall make the disclosures required under subsection (1) or
31 (2) of this section in the course of the solicitation but prior to
32 asking for a commitment for a contribution from the solicitee, and in
33 writing to any solicitee that makes a pledge within five days of making
34 the pledge. If the person or organization sends any materials to the
35 person or organization solicited before the receipt of any
36 contribution, those materials shall include the disclosures required in
37 subsection (1) or (2) of this section, whichever is applicable.

38 (4) In the case of a solicitation by advertisement or mass
39 distribution, including posters, leaflets, automatic dialing machines,

1 publication, and audio or video broadcasts, it shall be clearly and
2 conspicuously disclosed in the body of the solicitation material that:
3 (a) The solicitation is conducted by a named commercial fund raiser, if
4 it is; (b) the notice of solicitation required by the charitable
5 solicitation act is on file with the secretary's office; and (c) the
6 potential donor can obtain additional information at a toll-free
7 number.

8 (5) A container or vending machine displaying a solicitation must
9 also display in a clear and conspicuous manner the name of the
10 charitable organization for which funds are solicited, the name,
11 residence address, and telephone number of the individual and any
12 commercial fund raiser responsible for collecting funds placed in the
13 containers or vending machines, and the following statement: "This
14 charity is registered with the secretary's office under the charitable
15 solicitation act, registration number"

16 (6) A commercial fund raiser shall not represent that tickets to
17 any fund raising event will be donated for use by another person unless
18 all the following requirements are met:

19 (a) The commercial fund raiser prior to conducting a solicitation
20 has written commitments from persons stating that they will accept
21 donated tickets and specifying the number of tickets they will accept;

22 (b) The written commitments are kept on file by the commercial fund
23 raiser for three years and are made available to the attorney general
24 on demand;

25 (c) The contributions solicited for donated tickets may not be more
26 than the amount representing the number of ticket commitments received
27 from persons and kept on file under (a) of this subsection; and

28 (d) Not later than seven calendar days prior to the date of the
29 event for which ticket donations are solicited, the commercial fund
30 raiser shall give all donated tickets to the persons who made the
31 written commitments to accept them.

32 (7) Each person or organization soliciting charitable contributions
33 shall not represent orally or in writing that:

34 (a) The charitable contribution is tax deductible unless the
35 charitable organization for which charitable contributions are being
36 solicited or to which tickets for fund raising events or other services
37 or goods will be donated, has applied for and received from the
38 internal revenue service a letter of determination granting tax
39 deductible status to the charitable organization;

1 (b) The person soliciting the charitable contribution is a
2 volunteer or words of similar meaning or effect that create the
3 impression that the person soliciting is not a paid solicitor unless
4 such person is unpaid for his or her services;

5 (c) The person soliciting the charitable contribution is a member,
6 staffer, helper, or employee of the charitable organization or words of
7 similar meaning or effect that create the impression that the person
8 soliciting is not a paid solicitor if the person soliciting is
9 employed, contracted, or paid by (~~(an independent)~~) a commercial fund
10 raiser.

11 (~~(+5)~~) (8) If the charitable organization is associated with, or
12 has a name that is similar to, any unit of government each person or
13 organization soliciting contributions shall disclose to each person
14 solicited whether the charitable organization is or is not part of any
15 unit of government and the true nature of its relationship to the unit
16 of government.

17 (~~(+6)~~) (9) No person may, in connection with the solicitation of
18 contributions or the sale of goods, magazine, newspaper advertising, or
19 any other service, use the name "police," "sheriff," "fire fighter,"
20 "firemen," or a similar name unless properly authorized by a bona fide
21 police, sheriff, or fire fighter organization or police, sheriff, or
22 fire department. A proper authorization must be in writing and signed

24 (10) A person may not, in connection with the solicitation of
25 contributions or the sale of goods, magazines, or newspaper
26 advertising, or any other service, use the name of a federally
27 chartered military veterans' service organization unless authorized in
28 writing by the highest ranking official of that organization in this
29 state.

30 (11) A charitable organization shall comply with all local
31 governmental regulations that apply to soliciting for or on behalf of
32 charitable organizations.

33 (~~(+7)~~) (12) The advertising material and the general promotional
34 plan for a solicitation shall not be false, misleading, or deceptive,
35 and shall afford full and fair disclosure.

36 (~~(+8)~~) (13) Solicitations shall not be conducted by a charitable
37 organization or (~~(independent)~~) commercial fund raiser that has, or if
38 a corporation, its officers, directors, or principals have, been
39 convicted of a crime involving solicitations for or on behalf of a

1 charitable organization in this state, the United States, or any other
2 state or foreign country within the past ten years or has been subject
3 to any permanent injunction or administrative order or judgment under
4 RCW 19.86.080 or 19.86.090, involving a violation or violations of RCW
5 19.86.020, within the past ten years, or of restraining a false or
6 misleading promotional plan involving solicitations for charitable
7 organizations.

8 (14) No charitable organization or commercial fund raiser subject
9 to this chapter may use or exploit the fact of registration under this
10 chapter so as to lead the public to believe that registration
11 constitutes an endorsement or approval by the state, but the use of the
12 following is not deemed prohibited: "Registered with the Washington
13 state secretary of state as required by law. Registration number"

14 (15) No entity may engage in any solicitation for contributions for
15 or on behalf of any charitable organization or commercial fund raiser
16 unless the charitable organization or commercial fund raiser is
17 registered with the secretary.

18 (16) No entity may engage in any solicitation for contributions
19 unless it complies with all provisions of this chapter.

20 (17)(a) No entity may place a telephone call for the purpose of
21 charitable solicitation that will be received by the solicitee before
22 eight o'clock a.m. or after nine o'clock p.m.

23 (b) No entity may, while placing a telephone call for the purpose
24 of charitable solicitation, engage in any conduct the natural
25 consequence of which is to harass, intimidate, or torment any person in
26 connection with the telephone call.

27 (18) Failure to comply with subsections (1) through ((+8)) (17) of
28 this section is a violation of this chapter.

29 **Sec. 9.** RCW 19.09.190 and 1986 c 230 s 16 are each amended to read
30 as follows:

31 Every ~~((independent))~~ commercial fund raiser who (1) directly or
32 indirectly receives contributions from the public on behalf of any
33 charitable organization; or (2) is compensated based upon funds raised
34 or to be raised, number of solicitations made or to be made, or any
35 other similar method; or (3) incurs or is authorized to incur expenses
36 on behalf of the charitable organization; or (4) has not been
37 registered with the secretary as ~~((an independent))~~ a commercial fund

16 raisers shall maintain accurate, current, and readily available books

20 maintain a record of the names of donors, their addresses, and the date
21 the donations were received for one year after a solicitation campaign

35 days, following receipt of a written demand therefor from the attorney
36 general or county prosecutor.

3 Upon the request of the attorney general or the county prosecutor,
4 a charitable organization or commercial fund raiser shall submit a

20 **Sec. 12.** RCW 19.09.230 and 1986 c 230 s 14 are each amended to
21 read as follows:

22 No charitable organization, (~~independent~~) commercial fund raiser,
23 or other entity may knowingly use the name, symbol, or emblem of any
24 other person for the purpose of soliciting contributions from persons
25 in this state without the written consent of such other person. Such
26 consent may be deemed to have been given by anyone who is a director,
27 trustee, or other authorized officer, employee, agent, or
28 (~~independent~~) commercial fund raiser of the charitable organization,
29 and a copy of the written consent must be kept on file by the
30 charitable organization or commercial fund raiser and made available to
31 the attorney general upon demand.

32 A person may be deemed to have used the name of another person for

6 or other person soliciting contributions for or on behalf of a
7 charitable organization may use a name, symbol, emblem, or statement so
8 closely related or similar to that used by another charitable
9 organization or governmental agency that the use thereof would tend to
10 confuse or mislead the public. The secretary may revoke or deny any
11 application for registration that violates this section.

12 **Sec. 14.** RCW 19.09.275 and 1986 c 230 s 18 are each amended to
13 read as follows:

14 Any person who willfully and knowingly violates any provision of
15 this chapter or who willfully and knowingly gives false or incorrect
16 information to the secretary, attorney general, or county prosecuting
17 attorney in filing statements required by this chapter, whether or not
18 such statement or report is verified is guilty of a gross misdemeanor
19 punishable under chapter 9A.20 RCW.

4 affirmations, subpoena witnesses, compel their attendance, take
5 evidence, and require the production of any books, papers,
6 correspondence, memoranda, agreements, or other documents or records
7 which the attorney general deems relevant or material to the inquiry.

8 In case of willful failure on the part of a person to comply with
9 a subpoena lawfully issued by the attorney general or on the refusal of

10 registrations, reports, or other information filed under this chapter.

13 renewals of registration under chapter 19.09 RCW and annual reporting
14 under chapter 11.110 RCW. They shall report their findings, and any
15 recommendations for further statutory change, to the legislature by
16 January 1, 1994.

17 NEW SECTION. **Sec. 24.** The attorney general and the secretary of
18 state shall jointly develop and implement, prior to July 1, 1994, a
19 consolidated application for registration under chapters 11.110 and
20 19.09 RCW.

23 NEW SECTION. **Sec. 26.** Sections 17 through 22 of this act are each

25 NEW SECTION. **Sec. 27.** If any provision of this act or its
26 application to any person or circumstance is held invalid, the
27 remainder of the act or the application of the provision to other
28 persons or circumstances is not affected.

29 NEW SECTION. **Sec. 28.** This act is necessary for the immediate
30 preservation of the public peace, health, or safety, or support of the

1 state government and its existing public institutions, and shall take
2 effect July 1, 1993.
