1 AN ACT Relating to initiative and referendum petitions; and
2 amending RCW 29.79.090, 29.79.100, and 29.79.110.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 29.79.090 and 1982 c 116 s 9 are each amended to read
5 as follows:

6 Petitions for proposing measures for submission to the legislature
7 at its next regular session, shall be substantially in the following
8 form:

10 Every person who signs this petition with any other than his or her
11 true name, knowingly signs more than one of these petitions, signs this
12 petition when he or she is not a legal voter, or makes any false
13 statement on this petition may be punished by fine or imprisonment or
14 both.

24 address is correctly stated, and I have knowingly signed this petition
