- 1 AN ACT Relating to the integration of international medical
- 2 graduates into Washington's health care delivery system; creating new
- 3 sections; and providing an expiration date.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislature finds that a shortage
- 6 of primary care health care providers has created significant
- 7 provider access issues in Washington.
- 8 (2) The legislature further finds that international medical
- 9 graduates residing in the state could provide increased access to
- 10 primary care for state residents, but international medical graduates
- 11 routinely face barriers to practice.
- 12 (3) Therefore, the legislature intends to establish the
- 13 international medical graduate work group to study barriers to
- 14 practice and make recommendations on how the state can implement an
- 15 international medical graduate assistance program by January 1, 2022,
- 16 to assist international medical graduates in integrating into the
- 17 Washington health care delivery system.
- 18 <u>NEW SECTION.</u> **Sec. 2.** (1) Subject to the availability of amounts
- 19 appropriated for this specific purpose, the international medical

- graduate work group is established. The work group membership must consist of the following members appointed by the governor:
- 3 (a) A representative from the medical quality assurance 4 commission;
 - (b) A representative from the department of health, health systems quality assurance division;
 - (c) A representative from the University of Washington school of medicine graduate medical education program;
- 9 (d) A representative from the Washington State University Elson 10 S. Floyd college of medicine graduate medical education program;
- 11 (e) A representative from the Pacific Northwest University of 12 Health Sciences college of osteopathic medicine graduate medical 13 education program;
- 14 (f) A representative from a statewide association representing 15 physicians;
- 16 (g) A representative from the Washington state family medicine 17 residency network;
- 18 (h) A representative from a primary care health care employer in 19 a rural or underserved area of Washington;
- 20 (i) A representative from a health carrier offering coverage in a 21 rural or underserved area of Washington;
- 22 (j) A licensed physician with experience working with 23 international medical graduates;
- 24 (k) A representative from an organization specializing in refugee 25 advocacy in Washington;
- 26 (1) A representative from an organization serving refugee 27 physicians and international medical graduates;
 - (m) A representative from an organization offering counseling and educational programs to internationally trained health professionals;
- 30 (n) A representative from an organization representing community 31 and migrant health centers; and
 - (o) At least two international medical graduates.
 - (2) The work group must:

- 34 (a) Develop strategies and recommendations for reducing barriers 35 for international medical graduates obtaining residency positions in 36 Washington, including preresidency training;
- 37 (b) Make recommendations for the appropriate number of residency 38 positions to be designated for international medical graduates, and 39 the locations and specialties of those positions; and

- (c) Make recommendations on the postresidency service requirements for international medical graduates who graduate from a designated residency position.
 - (3) Staff support for the work group must be provided by the medical quality assurance commission.
 - (4) The work group must submit a report to the governor and the legislature with its recommendations by December 1, 2019.
 - (5) This section expires June 30, 2020.
