## Executive Summary

This annual report on Washington's homeless grant programs meets the reporting requirements of the 2005 Homelessness Housing and Assistance Act, RCW 43.185C,<sup>1</sup> for Calendar Year 2016 and State Fiscal Year 2017 (depending on the data source). This report also describes efforts to implement the goals in the state Homeless Housing Strategic Plan (Plan)<sup>2</sup> to reduce homelessness. Commerce awards grants to local governments and other service providers to deliver homeless housing services.

The homeless grant programs at Commerce are divided into two offices: the Office of Adult and Family Homelessness (OFAH) and the Office of Homeless Youth (OHY). This report describes the work of both offices during the reporting periods. It also includes reporting on document recording fees. The appendices contain required reporting on county spending and outputs, and the Point-in-Time Count results.

### Progress Toward Reducing Adult and Family Homelessness

Despite the statewide low vacancy rates, the Point-in-Time (PIT) count conducted in January 2017 indicates that the number of people living outside dropped in the majority of counties. However, counties with fast growing economies and rents continued to see increases in homelessness.

In Calendar Year 2016, over 122,000 people experiencing homelessness or housing instability in our state were provided housing assistance, other services, or both. These individuals encountered their county homeless crisis response systems that identify and prioritize people with the greatest need so they are quickly "screened in" for housing. The goal of a highly performing system is to reach the balance between need and capacity, so that when a person becomes unsheltered there is an immediate response that quickly moves that person back into housing.

The statewide homeless crisis response system housed 99,729 people experiencing homeless or housing instability last year. Twenty-six percent of people who exited a homeless program went into permanent housing. Further improvements to this level of performance, combined with lower rental inflation, adequate rental vacancy rates, and resources matched to need, could lead to Washington state achieving the vision of "leaving no person left living outside."

### Improving Practices

- In 2016, Commerce required counties to increase the number of people served who were unsheltered (as opposed to at-risk of being homeless) by at least 5 percentage

points or reach functional zero<sup>3</sup> for at least two sub-populations, such as families with minor children, veterans, unaccompanied youth, chronically homeless, and single adults. Most counties met or exceeded this expectation. Building off that success, Commerce has introduced additional performance measures and benchmarks for the new biennial grants to counties.

- Commerce required grantees to prioritize the use of document recording fees for housing unsheltered people, and created a benchmark that at least 35 percent of people assisted must have been unsheltered in the last two years; this included all domestic violence victims. Thirty-one of the 34 grantees met the required increase in serving unsheltered households, and four small rural counties may have met the criteria for achieving functional zero. While it is difficult to directly correlate the reduction in prevalence of unsheltered homelessness in the 2017 PIT to this requirement, this data may indicate that the policy change was successful.
- Commerce expanded the use of “flexible funding” to allow for payments of expenses that would directly help a homeless household obtain or maintain housing, as well as pay for permanent supportive housing for sheltered and unsheltered homeless households with disabilities. This additional flexibility allows communities to identify locally driven paths to meet the higher performance expectations added to state grants.

### **Improving Technical Assistance and Training**

Commerce initiated and continued several activities to support homeless service providers statewide in 2016.

- **County Report Cards:** twice yearly published performance reports for counties to use in reporting service outcomes and advocating for resources in their communities.
- **Vulnerability Assessment Tools Learning Community:** monthly webinar supporting peer network of homeless providers using the various vulnerability assessment tools.
- **Emergency Shelter Provider Network:** monthly networking for shelter providers to exchange ideas and support on shelter best practices.
- **Trauma Informed Care Trainings:** regional trainings on working with homeless people who have been impacted by trauma, and how to provide trauma-informed care and services at a programmatic and systems level. Over a dozen trainings on grant guidelines and best practices to grantee staff and their stakeholders were provided.

### **Challenges to Reducing Adult and Family Homelessness**

Counties with fast growing economies and rents continue to see increases in homelessness. The growing mismatch of incomes and housing costs is the primary contributor to growing homelessness in our state.<sup>4</sup>

### **Shortage of Affordable Housing**

According to a study by the National Low Income Housing Coalition (NLIHC),<sup>5</sup> the United States has a shortage of 7.4 million affordable rental homes available to extremely low-income renter households, resulting in 35 affordable and available units for every 100 extremely low-income renter households. The study also shows that Washington state is no exception, with less than the national average of affordable and available units per 100 extremely low-income households<sup>6</sup>. Because of the shortage of affordable and available homes, many lower income households are cost burdened, spending more on housing than they can afford without sacrificing other necessities.<sup>7</sup>

### **Lack of Living Wage Jobs**

In Washington, the fair market rent for a two-bedroom apartment is \$1,229. In order to afford this level of rent and utilities, without paying more than 30 percent of income on housing, a household must earn \$4,098 monthly or \$49,177 annually.<sup>8</sup> The NLIHC 2017 *Out of Reach* report indicates that while costs vary by region, a person would need to work 2.1 jobs at state minimum wage to afford a two-bedroom rental at fair market rent.

### **Challenges With Landlord and Community Support**

Across the state, as the vacancy rates become too low, homeless service providers are finding it more difficult to find affordable units for the people they serve. For years, communities have worked to strengthen relationships with local landlords and implement best practices around engaging community support. Service providers that operate programs accessible to all people living unsheltered face resistance in their communities to housing people who have behavioral health issues or criminal records. In some communities, local ordinances criminalize some of what for the homeless are life-sustaining activities.<sup>9</sup> These ordinances complicate the already difficult work of garnering community support and moving every person into housing.

### **Continuing to Improve**

Commerce improved upon the 2016 requirements and now counties are required to continue to increase the focus on housing unsheltered people. Commerce also adopted new system-wide performance requirements into the state-funded Consolidated Homeless Grant performance-based contracts. County Report Cards<sup>10</sup> posted on the Commerce website include progress on these performance measures.

These baseline measures provide the framework from which Commerce will evaluate performance of county homeless crisis-response systems. Commerce will continue to provide technical assistance and training to lower-performing counties and will continue to monitor and potentially sanction grantees that do not meet grant terms and conditions.

## Next Steps

Because increasing rents are the primary reason homelessness has grown in recent years,<sup>11</sup> Commerce has been working to identify policy changes to improve housing affordability in the state. Initiatives include supporting the work of the Housing Affordability Response Team (HART)<sup>12</sup> to identify policy and resources changes needed to improve housing affordability, and implementing legislative changes<sup>13</sup> to the Buildable Lands process, which will be used to ensure an adequate supply of building opportunities in urban counties.

The state Homeless Housing Strategic Plan<sup>14</sup> lays out specific actions Commerce is taking to continue improving: 1) the prompt identification and prioritization of people experiencing homelessness, and 2) the efficiency and effectiveness of housing provided.

As directed by the plan, Commerce is working with stakeholders to refine the model used to estimate the impact of policy changes and investments on the count of people living outside, and improve publically available analytical tools to aid in local strategic planning and system transparency.

## State Homeless Housing Strategic Plan

The Department of Commerce (Commerce) released the updated State Homeless Housing Strategic Plan in January 2017, and the 2018 plan is under development. The next annual report will include an update linking the goals in the plan to performance measurements and results.

The Office of Adult and Family Homelessness is responsible for seven primary goals in the plan, which includes strategies, actions, and performance measures. Each goal has an activity that directs the work of the Office and is used to measure progress. Additionally, the goals, excerpted from the Plan below, guide the office's work towards the vision that no person in our state is left living outside.

1. Effective and efficient coordinated access and assessment for services and housing.
2. Effective and efficient crisis response system as measured by cost per successful exit to permanent housing.
3. Identification of policy changes and resources necessary to house all people living unsheltered.
4. Quantification of what would reduce the number of new people becoming homeless.
5. Transparent and meaningful accounting of state and local recording fee funds.
6. Fair and equitable resource distribution.
7. Increased investments in housing unsheltered families with children, unsheltered chronically homeless people, and preventing youth from exiting public systems to homelessness.

### Improving Performance

In 2016, Commerce added a new system-wide performance measure to the Consolidated Homeless Grant contract that required counties to focus on housing unsheltered people. In 2017, Commerce also added new system-wide performance requirements in response to new requirements under RCW 43.185C.040<sup>15</sup> including:

1. Percent exits to permanent housing.
2. Length of time people remain homeless.
3. Returns to homelessness within two years of exit.

County Report Cards<sup>16</sup> posted on the Commerce website include progress on these performance measures and are reported twice annually at the state and county levels.

Commerce will continue to provide technical assistance and training to lower-performing counties and will continue to monitor and potentially sanction grantees that do not meet grant terms and conditions. The new performance measures are listed in Table 1.

## Document Recording Fee Expenditures

### Sampling and Reporting Required for All Document Recording Fee Expenditures

Since 2012, Commerce has been required to report on the expenditures of housing vouchers, housing placements, eviction prevention payments, rent to landlords, and the portion of those rents that come from document recording fees. Below is a summary of that data. Additional details by county are in Appendix A. Commerce staff performs the data collection and analysis for this purpose, using program administration funds.

## Independent Examination of State Document Recording Fee Expenditures

### Background

In 2014, the Legislature amended RCW 36.22.179(1)(b)<sup>17</sup> to require 45 percent of the state document recording fees be set aside for private, for-profit rental housing. That change also required the Office of Financial Management (OFM) to obtain an independent examination of state document recording fee spending, specifically to determine if the 45 percent requirement is being met.

### Results of the Independent Examination

The independent examination conducted by Reed and Associates CPAs for CY 2016, found that for the third year in a row Commerce exceeded the 45 percent set-aside requirement, with 76 percent expended for private rental housing.<sup>18</sup> The cost of the audit is approximately \$90,000 each year, or the equivalent of approximately 50 housing vouchers for homeless households.

Private landlords are crucial partners for local homeless service providers, yet source-of-income discrimination occurs when a landlord or property manager chooses not to accept tenants with means-tested government benefits, such as disability benefits, housing vouchers, or Temporary Assistance for Needy Families. Source-of-income discrimination is difficult to prove even where it is prohibited, and its prevalence is difficult to estimate. Source-of-income discrimination is prohibited in several jurisdictions in Washington, including the cities of Bellevue, Kirkland, Redmond, Seattle, Tumwater and Vancouver, and King County.<sup>19</sup>

Commerce-contracted homeless service providers continue to report that compliance with the budget categories required to track private rental housing payments is burdensome and diverts resources from assisting homeless households.

## Consolidated Homeless Grant

The Consolidated Homeless Grant includes funding appropriated to Commerce for homeless housing from the Home Security Fund, Affordable Housing for All Account, and Transitional Housing Operating and Rent Account.

The grant funding supports crisis response systems in every county across the state so that people who are experiencing homelessness quickly receive the right intervention and services, with the goal of making homeless episodes rare, brief, and one-time. The basic elements of a crisis response system include outreach and engagement, coordinated entry, diversion, emergency shelter, rapid rehousing, limited and targeted transitional housing, permanent housing, and permanent supportive housing.

Homeless services are provided through a network of faith-based organizations, community non-profits, and local governments that have experience working with property owners and managing rent assistance programs. Interventions primarily focused on housing stability for people living outside, have been shown to successfully reduce homelessness and achieve functional-zero homelessness when adequate to meet the need. Commerce uses the federal Homeless Emergency Assistance and Rapid Transition to Housing Act (HEARTH)<sup>20</sup> measures to review contract performance toward achieving an effective crisis response system and functional zero.

Consolidated Homeless Grant client data for CY 2016 is reported in Table 3. The housing interventions are federally defined and align with the data standards in the Homeless Management Information System (HMIS).

## Housing and Essential Needs Program

Housing and Essential Needs funds are incorporated into the Consolidated Homeless Grant and administered within the grant requirements guidelines, which include prioritizing unsheltered people with the greatest needs.

The Department of Social and Health Services determines eligibility for a “Housing and Essential Needs Referral” based on a person’s level of disability. Once a person has a referral, they can access assistance through their county’s homeless services coordinated entry system. Services are provided through a network of faith-based organizations, community non-profits, and local governments that have experience working with property owners and managing rent assistance programs.

Housing and Essential Needs funding is appropriated by state fiscal year from state general funds. The appropriation, spending, and number of clients assisted has remained steady since the program inception in November 2011.

Note: Commerce did not grant Housing and Essential Needs funds to several counties in SFY 2017 but instead increased their state funded consolidated homeless grant to assist Housing and Essential Needs referred clients. This was done so that smaller counties, such as San Juan, Whitman, Asotin, Wahkiakum, would have fewer small fund sources to manage that we could offset with additional state document recording fees.

# Office of Homeless Youth Prevention and Protection Programs

## Overview

The Legislature created the Office of Homeless Youth Prevention and Protection Programs (OHY) during the 2015 legislative session to “coordinate funding, policy, and practice efforts related to homeless youth.”<sup>21</sup> The OHY leads the statewide efforts to reduce and prevent homelessness for youth and young adults through five priority service areas to ensure our youth and young adults have:

1. Stable Housing – Every youth has a safe and healthy place to sleep at night.
2. Family Reconciliation – Families are reunited when safe and appropriate.
3. Permanent Connections – Youth have opportunities to establish positive, healthy relationships with adults.
4. Education and Employment – Youth have opportunities to advance in their education or training and obtain employment.
5. Social and Emotional Well-Being – Youth have access to behavioral and physical health care; services nurture each youth’s individual strengths and abilities.

During its first year, the OHY conducted extensive community engagement and research to understand the nature of youth homelessness across the state.

- A listening tour conducted in partnership with First Lady Trudi Inslee and A Way Home Washington<sup>22</sup> heard from community leaders, service providers, and young people on what is needed to prevent and end youth homelessness in their community.
- A partnership with Mockingbird Society’s Youth Advocates Ending Homelessness (YAEH) to engages with young people on a quarterly basis, and through the Annual Youth Leadership Summit to receive input and guidance on solutions to address youth homelessness.
- The OHY advisory committee, a statewide coalition of youth service providers and advocates, as well as state agency partners, helps shape the office’s efforts.
- To strengthen knowledge in the field, the OHY and A Way Home Washington commissioned a comprehensive research report, *Youth Homelessness in Washington, Landscape Scan*.<sup>23</sup> The report included an analysis of available data, gaps in systems addressing youth homelessness, and recommendations.

Through these initiatives, the OHY developed a set of policy, funding, and practice recommendations to prevent and end youth homelessness in its *2016 Report to the Governor and Legislature*.<sup>24</sup>

In January 2016, the OHY began oversight of shelter and outreach programs for youth, previously managed by the Department of Social and Health Services. The 2016 Supplemental Budget included \$3.7 million in additional funding to expand existing programs for youth under age 18 and provide new funding to serve young adults, age 18 through 24. With the new funding, the Office of Homeless Youth launched a shelter program and a housing program for young adults, which began serving participants in September of 2016.

Through these programs, the Office of Homeless Youth served 3,948 youth and young adults between July 1, 2016, and June 30, 2017. Of those served through a shelter or housing program, an average of 39 percent exited to safe and stable housing.

### OHY Programs and Performance

The Office of Homeless Youth manages grants for programs targeted to two age groups – youth under age 18, and young adults age 18 to 24.

#### Programs that serve youth under age 18

- **Crisis Residential Centers** provide short-term, semi-secure, and secure facilities for runaway youth and adolescents in conflict with their families.
- **HOPE Centers** provide temporary residence, referrals and permanency planning for street youth.
- **Street Youth Services** connect youth to services and housing through street and community-based outreach.

#### Programs that serve young adults, ages 18 to 24

- **Independent Youth Housing Program** provides rental assistance and case management for youth who have aged out of the foster care system.
- **Young Adult Housing Program** provides rental assistance, transitional housing, and case management for homeless young adults.
- **Young Adult Shelter** provides emergency shelter beds to young adults.

## Efforts Underway or in the Planning Stages for 2017 and 2018

- **Criminal Justice Training Program:** a program launched in July of 2017 to train criminal justice personnel on best practices to identify and engage homeless youth, and the laws governing the intersection of law enforcement and homeless youth.
- **Preventing exits from public systems into homelessness:** through funding appropriated in the 2017-19 state operating budget, the OHY will fund projects that test innovative approaches, services, or program models that prevent youth from exiting foster care, behavioral health, or the criminal justice system into homelessness.

- **Performance measures:** The OHY is moving towards a performance-based system to address youth homelessness. Shifting towards a focus on outcomes allows for continued improvement and progress towards program and system-wide goals to prevent and end youth homelessness. Beginning Jan. 1, 2018, OHY will measure data on a wide set of outcomes for each of its programs. Beginning Jan. 1, 2019, the OHY will adopt a set of measures to serve as performance standards, which will be used to evaluate grantee performance.
- **Policy development:** through the creation of a subcommittee of the OHY Advisory Committee, efforts are underway to develop a proposal for a public system response for youth under age 18 who are at risk or experiencing homelessness that is accessible, on demand, and has the capacity to provide needed services. The proposal will serve as a prevention and intervention strategy for youth homelessness, with a focus on supporting families and youth who are in crisis or need support.

## Independent Youth Housing Program

The Legislature created the Independent Youth Housing Program (IYHP) in 2007<sup>25</sup> to provide rent assistance and case management to youth ages 18 to 23 years old who have exited the state dependency system. The Legislature appropriated \$1.8 million from the state Home Security Fund during the 2015-17 Biennium. The success of the Independent Youth Housing Program is measured in the Homeless Management Information System using the outcomes reported in Table 8 as required under RCW 43.63A.311.<sup>26</sup> Table 9 provides a county-by-county breakdown of participant outcomes for IYHP.
