Executive summary

Authorizing legislation

The Legislature directed Commerce to prepare a report summarizing progress in issuing grants for community behavioral health facilities in Section 1023(11), Chapter 474, Laws of 2023 (the <u>2023-25 State Capital Budget</u>):

(11) The department must provide a progress report to the appropriate committees of the Legislature by September 1, 2024. The report must include:

- a) The total number of applications and amount of funding requested;
- b) A list and description of the projects approved for funding including state funding, total project cost, services anticipated to be provided, bed capacity, and anticipated completion date;
- c) A statewide map of new capacity since 2018, including projected bed capacity and opening dates;
- d) A status report of projects that received funding in prior funding rounds, including details about the project completion and the date the facility began providing services; and
- e) Recommendations for statutory language that would codify the grant program on an ongoing basis including:
 - i) Evaluation and prioritization criteria;
 - ii) Monitoring and compliance requirements;
 - iii) Preconstruction and technical assistance services; and
 - iv) Data needed to determine the service needs by area of the state.

This report provides details about the progress of creating new behavioral health facilities, including the number of new projects funded through the BHF Program, their status, cost, location and services provided. In addition, it will present recommendations on opportunities to codify the BHF program and shift its authority from budget proviso to statute.

Program history

Commerce's Behavioral Health Facilities (BHF) Program funds community-based behavioral health facilities in all parts of the state. The number of appropriations (see Figure 1) and grants awarded has increased in recent biennia as the state looks to close the gap between the number of adults and children needing behavioral health treatment, and the limited treatment options available. Gov. Inslee's <u>behavioral health plan</u> calls for more community-based treatment options as the state works to transition civilly committed individuals away from large institutional settings.



Figure 1: Behavioral Health Facility appropriations, by biennia

Behavioral health facilities provide a variety of services licensed by the Department of Health, contracted by the Department of Social and Health Services or, as in the past, contracted by the Department of Children, Youth and Families. All facilities serve individuals who receive publicly-funded healthcare as a condition of the grant agreement with Commerce.

Summary of 2023-25 competitive awards

In the 2023-25 biennium, BHF received 80 funding requests for nearly \$280 million across its competitive programs, and invested more than \$55 million in 22 projects. These investments will create up to 102 new beds, and preserve nearly 250 others. These investments also include the creation or expansion of 11 outpatient facilities, and the preservation of another.

It is important to note that while BHF did award only 28% of all applications, many projects did not qualify for funding for various reasons. To illustrate, BHF awarded nearly 70% of qualified <u>regional needs</u> applications, and 100% of qualified <u>intensive behavioral health</u> applications.

Investment figures and outcomes do not include direct appropriations, which include more than \$222 million in projects that strive to add approximately 250 new beds and create or sustain 6 additional outpatient facilities.

The complete list of projects approved for funding are included in the <u>Table 1</u> below, and <u>Appendix</u> B contains parallel summaries over the history of BHF. Full descriptions of projects receiving funding, by treatment category are provided alongside maps in <u>Appendix A</u>. As of the writing of this report, all competitive funds have been awarded, except the \$4.25 million provided to increase access to opioid treatment program that is currently in the application stage and has not yet been awarded. In addition, while there were many intensive behavioral health facility providers seeking funding, only one project qualified for an award.

Recommendations

While the BHF Program has significantly increased the number of community-based facilities in our state, Commerce has several recommendations to improve the program and the state's capacity to meet our shared goals in transforming Washington's behavioral health care system:

- Commerce recommends that the Legislature continue making improvements to address the behavioral health workforce shortage.
- State partners should continue to ensure Medicaid reimbursement rates for behavioral health services are adequate for sustainable facility operations.
- Accurate facility need data is necessary to understand Washington's behavioral health gaps and the facilities each region needs to address them. Commerce will develop a funding request for the 2025-27 biennium so that <u>Behavioral Health-Administrative Service Organizations</u> can appropriately identify the needed facilities and bed capacity for each region.¹
- Consider the suggested options for codifying the Behavioral Health Facilities program provided later in this report, and allow more time for Commerce to develop collaborative solutions with partner agencies so that we may create a consistent and sustainable program.

Introduction

Background

One in four Washingtonians lives with a behavioral health disorder. However, **more than half of all adults in America with a behavioral health disorder do not receive any treatment**. Washington ranks 32nd in the country for overall access to behavioral health care and 40th in youth access to care. Moreover, a growing percentage of youth live with major depression with 19% of Washington youth experiencing a major depressive episode in the past year, while only about 42% of those experiencing depression received any kind of treatment.⁸

These data points underscore the need to transform the state's behavioral health care system. Washington's initial <u>five-year plan</u> aimed to transform Western and Eastern State hospitals into forensic mental health treatment hospitals, while transitioning and diverting civilly committed individuals from state hospitals toward community-based treatment settings. Many mental health experts favor community-based treatment because it provides individuals better access to vital supports like employment, housing, proximity to family and community resources as opposed to monolithic institutional settings.

Commerce's Behavioral Health Facilities program (BHF) plays a key role in developing new communitybehavioral health facilities. The program's goal is to fund behavioral health facilities that offer different types of services to meet the varying treatment needs of individuals. Some of these services include:

- Children and minor youth: Inpatient or outpatient behavioral health facilities that serve children and minor youth
- **Crisis stabilization:** Short-term facilities that assess, diagnose, and treat persons experiencing an acute crisis without the use of hospitalization or jail
- **Dementia care:** Facilities that provide specialized long-term care services for persons with dementia
- Enhanced services facilities: Residential long-term care facilities that provide support and services to persons for whom acute inpatient treatment is not medically necessary
- Evaluation and treatment: Facilities that provide court-ordered inpatient treatment
- Intensive behavioral health treatment: Residential facilities that provide 24-hour supervision and specialized treatment for individuals with behavioral health conditions
- Secure withdrawal management and stabilization: Secure facilities serving individuals with likelihood of serious harm or who are gravely disabled due to a substance use disorder
- **Outpatient treatment:** Non-residential facilities that provide behavioral health treatment to individuals, groups, or families addressing a variety of needs.
- Peer respite: Peer run facilities for short-term, voluntary, non-crisis services

BHF supports community providers by helping them to construct, renovate or acquire property to expand capacity for behavioral health support facilities like these. An advisory group of providers and the state Department of Health, Department of Social and Health Services, and the Health Care Authority review and support funding decisions. To date, BHF has invested more than \$730 million to finance more than 2,900 treatment beds and 53 outpatient facilities across these categories of behavioral health care.

Behavioral Health Facilities Program overview

The Behavioral Health Facilities (BHF) Program provides grants to eligible organizations to **construct, renovate or acquire property to expand behavioral health service capacity.** All projects funded through BHF must commit to provide behavioral health services for at least 10 years (15 years for projects funded in the 2021-23 biennium).

Commerce awards grant funds both through a competitive process and direct appropriations specifically designated for funding by the Legislature, as well as non-competitive funding for closure prevention as appropriated in the 2023-25 State Capital Budget. Nonprofits, for-profit businesses, public entities and tribes are all eligible to apply during the funding rounds. Funding for the program has increased as the state has prioritized community-based treatment and Commerce strives for geographic diversity when selecting projects.

Commerce relies heavily on its state and local partners and behavioral health subject matter experts to inform BHF funding decisions. Our partners help score applications received during competitive funding rounds and participate in monthly Behavioral Health Facilities Advisory Group meetings. Representatives on the BHF advisory group include:

- Department of Social and Health Services (DSHS),
- Health Care Authority (HCA),
- Department of Health (DOH),
- Association of County Human Services,
- Managed Care Organizations (MCO),
- Accountable Communities of Health (ACH), and
- Behavioral Health Administrative Service Organizations (BH-ASO)

Each of these advisory group members help Commerce craft or refine application questions, provide technical assistance to applicants and grantees, and score funding proposals. Commerce also coordinates closely with our state agency partners to align program guidelines and operating funds for the BHF-funded facilities. All facilities are licensed by either DOH or DSHS, depending on the facility type.

The BHF-funded projects are grouped into the following six facility categories. The number of beds added to the state's capacity for the relevant licensed or contracted services is included in parenthesis.

- 1) Crisis Behavioral Health Treatment facilities are licensed by DOH to provide crisis stabilization services or evaluation and treatment services to adults or youths. (1,063 beds)
- 2) Long-Term Behavioral Health Treatment facilities are licensed by DOH to provide intensive behavioral health treatment or by DSHS as an enhanced services facility or an assisted living facility with community stability supports or Specialized Dementia Care Program contracts. (903 beds)
- 3) **Other Behavioral Health** facilities are licensed by DOH to provide mental health peer respite services or residential and inpatient services for mental health. (**128 beds**)
- 4) **Outpatient Treatment** facilities are licensed by DOH to provide outpatient services for crisis stabilization, mental health, substance use disorder, and/or youth. **(53 facilities)**
- 5) Substance Use Disorder Treatment facilities are licensed by DOH to provide residential and inpatient services for substance use disorder or secure withdrawal management and stabilization services to adults or youths. (648 beds)

6) Blended behavioral Health and Substance Use Disorder Treatment facilities provide both crisis stabilization services, evaluation and treatment services, or residential and inpatient services for mental health and residential and inpatient services for substance use disorder or secure withdrawal management and stabilization services to adults or youths. (172 beds)

Closure prevention

In the <u>2023-25 State Capital Budget</u>, Commerce received a \$7.5 million appropriation for a new BHF offering: closure prevention. Five community facilities received all of the first come, first served closure prevention funds, which will maintain 236 behavioral health beds and fortify the continuity of services at an outpatient facility that anticipates serving 1,000 individuals in 2024.

Grantees requested funds for structural repairs, fire protection system upgrades, and other renovations to sustain the health, safety, and security of patients and staff at their facilities. Two grantees will replace outdated plumbing. Another two grantees will repair roofs (another grantee replaced their roof with federal funding), while three recipients will upgrade their fire protection system; and one will replace a crumbling retaining wall and parking lot.

Three of the four grantees operating residential treatment facilities requested funds for HVAC system upgrades in their facility. Grantees cited the need to evacuate patient rooms due to excessive heat and the need for better filtration to reduce the spread of infectious diseases when requesting these upgrades.

The urgency of the requests ranged from critical for a facility that would not pass its next fire inspection to preventative repairs and upgrades that would sustain structural integrity and the health, safety, and security of patients and staff at their facilities. Many grantees attested that these are long overdue improvements that address safety concerns for patients and staff. Most grantees operate at a profit loss while others operate within a tight margin, demonstrating their need for external funding sources to accommodate these capital improvements.

Behavioral health facilities project highlight



Jamestown S'Klallam Outpatient Facility

The Commerce-funded, **Medication Assisted Treatment Facility**, in Sequim, opened in 2022. The project received a \$7.15 million grant from Commerce, which combined with \$10 million in non-state funds. The facility provides comprehensive patient care for people with Opiate Use Disorder. The project is part of a healing campus that includes counseling, transportation, child care, medical, and dental care. Future Commerce investments at the campus will include a 16-bed evaluation and treatment facility.

- The Jamestown S'Klallam Tribe worked tirelessly with the community in Clallam County to ease concerns about this facility t. Over time and with continuous engagement, support has grown significantly and patients are receiving holistic care in Sequim.
- At the <u>August 2022 grand opening</u> for the facility, W. Ron Allen, Tribal Chairman/CEO of the Jamestown S'Klallam Tribal Council, said "When they see the results of our services, they will know (its value). It is about healing. It is a journey for us and the journey only begins in terms of what it's going to do for our peninsula. There are many, many people who need our help and that's what we're here to do."
- Clallam County Commissioner, Mark Ozias, reiterated the journey this facility had taken. "This place is already starting to become the beating heart that is starting to heal the divisions this town has suffered," Ozias said. "I hope that it provides a guide for us more broadly as communities like ours strive to heal themselves at such an important time in our history."

Continuous improvement: Progress and opportunities

In the 2023-2025 biennium, Commerce began a review of the Behavioral Health Facilities Program (BHF) with the goal to make programmatic improvements and identify additional barriers and corresponding strategies or interventions that could improve Washington's behavioral health system.

Commerce made significant process and program improvements that are complementary to the required recommendations to codify the BHF program.

Program improvements

BHF developed and adopted several strategies to improve the program's effectiveness surrounding program administration and data quality.

- Revised the BHF application review and approval process, including to require community and regional engagement.
- Improved internal data quality and data systems
- Updated program guidance materials and process documents
- Improved project monitoring and data verification with support of ongoing <u>behavioral health utilization</u> reporting, including to:
 - Align BHF program data and terms with those of state partner agencies.
 - Adjust bed counts to remove duplicates.
 - Confirm construction completion dates with DOH Construction Review Services.
 - Confirm the services that BHF grantees provide with DOH behavioral health license data.
 - Confirm inpatient care services with DOH residential treatment facility license data and DSHS provider lists.
 - Align BHF facility categories with the facility's licensed services.

These improvements support role clarity for the state partners that participate with BHF, enhance Commerce's ability to understand facility utilization (such as licensing and service data) after BHF investment, and to solicit stronger applications. However, Commerce is also considering additional program improvements that will be necessary to continue successfully building additional behavioral health service capacity in Washington communities.

- Developing a Commerce quality assurance team to support grantees to effectively complete their awarded projects.
- Programmatic development to create an on-ramp for prospective behavioral health providers to understand the landscape of providing services in Washington and successfully operate a facility.

BHF identified three additional opportunities for improvement. Each intersects with the <u>recommendations to</u> <u>codify the BHF program</u> and are detailed below.

- Assessing the need for facilities across the state and in collaboration with BH-ASOs.
- Additional BHF programmatic capacity for pre-design and pre-development grants that will ensure large state investments are feasible.
- Continued collaboration with HCA and DSHS on proactive approaches during the screening process to ensure BHF-funded projects will not be determined to be Institutions of Mental Disease (IMD) after a project is awarded funding. Facilities determined to be IMDs cannot accept federal funding, and in the absence of state operating support, cannot maintain operational integrity.

Opportunities for continuous improvement

These recommendations are prospective improvements focused on Washington's behavioral health system, rather than specific to BHF, and largely require external collaboration and support from Commerce's state partners, or the Legislature.

• Commerce recommends that the Legislature continue making improvements to address the behavioral health workforce shortage.

In BHF outreach and engagement activities, team members consistently hear from providers interesting in applying, because they see the need for more services and want to fill that gap. However, providers are communicating to Commerce that the **current workforce shortages are an obstacle from applying for a Commerce grant** and expanding their services. Providers are concerned about finding enough qualified staff to operate facilities for the full 10-year commitment period. Prospective providers have also expressed the need for workforce housing so that their staff can live close to where they work. This is not a problem unique to the behavioral health workforce, but is an important consideration for prospective facility operators when making plans for new facilities, especially in Washington's behavioral health deserts where care is not readily available.

Growing the state's toolkit to support the behavioral health workforce through <u>behavioral health scholarships</u> (Chapter 369, Laws of 2024) and by easing <u>licensing and credentialing requirements</u> (Chapter 271, Laws of 2024) are examples of initiatives that will increase workforce participation.

• State partners should continue to ensure Medicaid reimbursement rates for behavioral health services are adequate for sustainable facility operations.

Grantees have reported that Medicaid reimbursement rates for behavioral health services are possibly not adequate to provide the necessary standard of care their patients deserve and maintain a healthy business. Continuing to evaluate Medicaid reimbursement rates for behavioral health services will create the conditions for Behavioral Health Facilities grantees to follow through with their commitment to the state and to the Washingtonians they serve.

• Accurate facility need data is necessary to understand Washington's behavioral health gaps and the facilities each region needs to address them. Commerce will develop a funding request for the 2025-27 biennium so that Behavioral Health-Administrative Service Organizations can appropriately identify the needed facilities and bed capacity for each region.

While Washington is making great strides to understand the utilization of current facilities, the need for new facilities and the specific, required treatments is less defined. Commerce recognizes this limiting factor and will develop a budget request to support each regional BH-ASO to assess the need in their region. Such assessment would likely need to be updated regularly, such as every 5 years, so that we can be as adaptive as possible to treatment needs and how they evolve across each region.

Moreover, this assessment would be instructive as a two-way influence on the state policy process and on provider siting and investment. This work would serve as an informed baseline for future BHF capital funding requests, to maintain a high level of visibility on the problem, and demonstrate how each region is addressing it. Washington needs more behavioral health providers and prospective providers could use these regional needs assessments to consider whether the kinds of facilities needed can match their expertise and operational ability to staff and manage them. It would also make clear the opportunities that are available for

new providers interested in entering Washington's behavioral health ecosystem, and focus business plan and proposal development.

• Consider the suggested options for codifying the Behavioral Health Facilities program provided later in this report, and allow more time for Commerce to develop collaborative solutions with partner agencies so that we may create a consistent and sustainable program.

The section that follows provides a detailed examination of this recommendation.

Recommendations to codify the BHF Program

Background

The Commerce Behavioral Health Facilities Program (BHF) was directed to include recommendations to codify the grant program on an ongoing basis. Specifically, the Legislature directed Commerce to recommend approaches to meet specific criteria:

- Evaluation and prioritization criteria
- Monitoring and compliance requirements
- Preconstruction and technical assistance services
- Data needed to determine the service needs by area of the state

The BHF Program at Commerce is currently not in statute and is funded directly through appropriations in the capital budget each biennium with additions and changes each supplemental budget. These recommendation are intended to inform an ongoing conversation, rather than serve as discrete recommendations for change now. Given the unique and interdependent nature of BHF for the Health Care authority, Department of Health, Department of Social and Health Services and Commerce, specific statutory language will necessitate additional stakeholder coordination.

While the following considerations make significant progress toward codifying BHF in state statute, gaps do remain that will require additional time and engagement.

Overview

A Commerce BHF Program must focus on communities' regional needs, which is the flexible category used for a wide range of community behavioral health capacity grants and to create new capacity or make facility updates. In addition, after the success of the initial Closure Prevention Program (2023-25), Commerce sees great value in continuing this first come, first served offering that provides necessary maintenance funds to prevent the imminent closure of existing facilities. These considerations drive the scope of <u>eligible activities</u> detailed below.

Providing funding to the broad category of regional needs enables community hospitals and providers to address the need for services specific to their area. This approach can enhance the understanding of community behavioral health needs that would come from the <u>recommended needs assessment</u>. If recurring funding were available to conduct these assessments at discrete intervals, such as every five years, the state would be well positioned to identify the service gaps and needed treatment capacity in advance of the biennial budget cycle. By adopting the approach to make a broad category of funding available that is informed by the need for specific facility types, the state can remove much of the uncertainty and guesswork for policymakers and providers to directly address community behavioral health needs.

Commerce may require rulemaking authority in any proposed legislation, but it should not be a requirement given the established criteria the program has inherited in capital proviso over the last decade. Much of the new territory for statutory recommendations, from interagency collaboration and technical assistance to match, can be established by memorandum, charter, or program guidelines.

Funding approaches

All projects would be evaluated according to provider and project eligibility and readiness to proceed to construction, which includes the commitment for all project funding at the time of application. Biennial funding

rounds will establish new capacity and maintain or stabilize current bed capacity for behavioral health services. The program could be set up in two different funding approaches: a funding cycle or list model.

- A funding cycle model allows the program to maintain operating as it currently does in proviso. Commerce receives funds as allocated through the capital budget process, and opens competitive funding rounds each year based on the amount funding appropriated. Applications will be ranked, and awarded according to the interagency advisory group, which conducts subject matter expert evaluations. If an award is declined, Commerce may use those funds to award the next project(s) on the ranked list, or would open a subsequent funding cycle later that biennium.
- The list model is similar to other competitive capital programs in Commerce. Commerce will solicit and evaluate applications for shovel ready projects each even-numbered year, and submit a prioritized funding list for consideration in each biennial capital budget. Applications will be reviewed and ranked by the interagency advisory group, which conducts subject matter expert evaluations. The list would include a description of each project, the amount of recommended state funding, demonstrated need for the facility and documentation of non-state funds to be used for the project.

The approaches have tradeoffs. Both processes are competitive in nature, and the list model would limit funding availability to once each two-year budget period. Given the expanding practice of legislative direct appropriations to the BHF Program, the list model would be a complementary approach that ensures project viability and readiness for selected projects. While the funding cycle model is more time intensive for staff and applicants alike, it provides greater flexibility for investing in community-based behavioral health needs.

Eligible entities:

Commerce does not recommend any changes to eligible entities. Those entities eligible to receive BHF awards now would be provided as eligible in statute, too.

- Currently licensed behavioral health service providers
- Educational service districts licensed to provide behavioral health services
- Local governments
- Federally recognized tribes

Any entities with existing Commerce contracts must be in good standing with no active requests to cure contractual concerns.

Eligible projects:

Grant-funded facilities must be licensed or eligible for licensure as a Behavioral Health Agency through DOH, or as an Enhanced Services Facility, an Assisted Living Facility with Community Stability Supports or Specialized Dementia Care Program contracts through DSHS.

Behavioral Health Agency (BHA) and prioritization of facility type will be based on regional need. Facilities funded through this program must provide behavioral health services as their primary purpose.

The Behavioral Health Facilities program, as currently outlined in its capital budget proviso, only allows Commerce to fund projects that are not subject to federal funding restrictions that apply to institutions of mental diseases. Commerce recommends that all projects that are able to receive public funds be eligible for BHF funding.

Eligible activities:

Commerce recommends that eligible activities remain consistent with other capital programs, including the ability to finance pre-construction costs, such as for new or prospective providers, which can establish a program pipeline, increase project readiness and quick deployment of construction funding. In addition, after the successful implementation of the <u>closure prevention pilot program</u>, this activity should continue as an eligible activity in any BHF statute.

- **Pre-construction.** Allows eligible entities to secure professional services to plan for and assess the feasibility of behavioral health facilities projects or receive other technical assistance to design and develop projects for construction funding and perform initial groundwork to advance from planning to eventual major construction or renovation. Examples include:
 - Technical studies, program studies, architectural or engineering services, design or schematic development, environmental/hazardous materials assessments, impact/mitigation studies or fees, archeological or historic surveys, geo-technical reports, construction cost analysis, land use applications, sustainability assessments, public capital facilities fees and feasibility studies.
- **Minor renovation.** Allows eligible entities to make necessary renovations that will expand capacity or maintain the facility's licensure.
- New construction, renovation, acquisition. Allows eligible entities to develop a new facility, add to an existing facility, renovate an existing facility, and/or purchase a property to renovate or construct a behavioral health facility.
- **Closure prevention and maintenance.** Allows eligible entities to access non-competitive funding to address emergent issues that, if left unaddressed, will result in the facility no longer being able to operate at capacity.

Match recommendations

Commerce proposes that a match element be considered in statute. Currently, BHF grants do not cover the entire cost for many awarded projects, and Commerce does not currently require a match. Rather, Commerce evaluates whether an applicant has secured all funds necessary to complete a usable phase of a project. A match requirement can help to ensure that applicants have realistic expectations of the funding commitment required to complete the project. However, behavioral health providers are often operating on slim margins, and a match requirement could prove detrimental to small and new providers alike. For this reason, Commerce recommends that its authority to require matching funds is written broadly to give Commerce the option to require match funding up to a pre-determined percentage. The match percentage would be adopted in program guidelines, which are revised each funding cycle, to ensure maximum flexibility for Commerce and community behavioral health projects. Match would also continue to be a key component of the evaluation criteria in the Commerce application process.

Match could include cash, the value of real property when acquired solely for the purpose of the project, in-kind contributions, along with other state federal, private or local government funding.

Interagency coordination and technical assistance

Commerce has subject matter expertise in grants management and administration, capital construction and readiness to proceed. However, Commerce is not the behavioral health subject matter expert. Rather, the departments of Health, Social and Health Services, and the Health Care Authority are the three state agencies that possess critical expertise in supporting the development of community behavioral health capacity and treatment services. In partnership with these agencies, representatives from community behavioral health

organizations, such as managed care organizations, accountable care organizations, and the Association of County Human Services serve as the Behavioral Health Advisory Group.

While Commerce reviews applications for capital infrastructure risk and feasibility, our partners on the advisory group review applications for feasibility and fidelity to facility-specific operation standards and best practices. The state agency members of the advisory group appoint subject matter experts (SMEs) from their agency to review applications. SMEs will represent their respective agency and serve as liaison between the application review team and their agency's leadership.

Formalizing participation of the advisory group, in alignment with the aforementioned evaluation and prioritization criteria, is a necessary condition to sustain successful state funded behavioral health projects. The scope of the advisory group's responsibilities must also be identified, including specific references to technical assistance so that we may remain accountable to a unified mission. A clear scope will also assist current and prospective providers in understanding who can assist with specific aspects of community behavioral health expansion. The authority for pre-construction funding will deepen the need for community technical assistance of facility design standards, as well as licensing and designation. It will also provide a clear connection to how operations funding is considered before providers even apply for capital construction, renovation or acquisition funding.

These collaboration needs will require additional interagency discussion and development to identify specific statutory references to achieve technical assistance and accountability goals.

Evaluation and prioritization

In awarding funding for projects, Commerce, in coordination with the SMEs from the Department of Social and Health Services, the Health Care Authority, and the Department of Health will establish criteria for the evaluation of funding requests, which will include:

- Evaluation of a prospective facility's status as an Institution of Mental Disease.
- Evidence that the application was developed with support by one or more managed care organizations and/or evidence that the application was developed with support from one or more Behavioral Health Administrative Service Organizations depending on facility type, as applicable.
- Evidence that the application was developed with support from the local community within which the project will be sited, including any local Association of County Human Services.
- Evidence that the applicant has assessed and would meet gaps in geographic availability of behavioral health services in their region.
- Evidence that the applicant is able to meet applicable licensing and certification requirements in the facility that will be used to provide services.
- A commitment by applicant to serve persons who are publicly funded and persons detained for involuntary commitment under chapter 71.05 RCW.
- A commitment by the applicant to maintain and operate the beds or facility for a time period commensurate to the state investment, but for at least a 10-year period.
- The date upon which structural modifications or construction would begin and the anticipated date of project completion.
- A detailed estimate of the costs associated with opening treatment beds.
- A financial plan demonstrating the applicant's ability to maintain and operate the facility for a time period commensurate to the state investment, but for at least a 10-year period.
- The applicant's commitment to work with local courts and prosecutors to ensure that prosecutors and courts in the area served by the hospital or facility will be available to conduct involuntary commitment hearings and proceedings under chapter 71.05 RCW, as allowable by facility type.

In addition to these evaluation criteria are at least five other considerations, which would be used to prioritize investments in community behavioral health.

- 1) Evidence that the project will result in increased behavioral health care capacity in a region where capacity is needed.
- 2) Evidence that if grant funds are awarded, the applicant has secured the remainder of the funding necessary to complete the project.
- 3) The extent to which the project leverages other funds.
- The extent to which the applicant is in good standing with current or previous behavioral health project awards.
- 5) Other criteria that Commerce considers necessary to achieve the state's community behavioral health expansion goals.

Monitoring and compliance recommendations

To be eligible to receive behavioral health facilities grant funding, applicants must:

- Commit to serving individuals receiving public funding
- Demonstrate that the project site is under the applicant's control for a minimum of 10 years, either through ownership or a long-term lease
- Commit to maintain and operate the facility funded by the grant for the purposes of providing behavioral health services for a minimum of ten years
- Upon completion of the project, the recipient must become licensed by the appropriate authorities, maintain that licensure, and provide behavioral health services for a minimum of 10 years
- If the recipient does not meet the conditions specified in statute, the grants shall be repaid, as directed by Commerce

Data necessary to determine service needs

Commerce will require assistance from our partner agencies and from regional BH-ASOs and Managed Care Organizations (MCOs) to ensure that we have access to the data necessary to determine service needs. The collaborative report to understand <u>behavioral health utilization</u> requires the Health Care Authority, Commerce, and the Department of Health to work with the Department of Social and Health Services to track behavioral health beds in the Health Executive Management Information System. This project has been informative and has promoted greater alignment between the data Commerce tracks and state licensing data. However, more information is needed to determine the need for new facilities.

Commerce recommends that it has the authority to consult with BH-ASOs to determine regional service needs, including to contract for this purpose. This recommendation is in alignment with the <u>opportunity to obtain</u> <u>accurate facility data</u> and Commerce's 2025-27 budget request to begin this initiative, and it would enhance the state's ongoing behavioral health utilization efforts.




Figure 2: Crisis behavioral health treatment facilities





Figure 5: Substance use disorder treatment facilities


