#### SUBJECT: LOCAL BUSINESS LICENSING PROGRESS REPORT

The Department of Revenue (Department) prepared the attached report in compliance with <u>RCW 35.90.020(8)</u>, which requires the Department to report on the progress of our efforts to partner with all cities that impose a general business license. <u>Chapter 35.90 RCW</u> requires Washington cities and towns with general business licenses to join a combined licensing system, either the Department's Business Licensing Service or the local online tax and licensing portal known as "FileLocal."

- Any recommendations to further simplify the issuance and renewal of general business licenses by the Department.
- Any other information the Department considers relevant.

# **SUMMARY**

The January 1, 2022, Business Licensing Progress Report was prepared by the Department of Revenue (Department) to comply with RCW 35.90.020(8). The law requires:

- A list of cities that have partnered with the Department as required in <u>RCW 35.90.020(1)</u>;
- A list of cities that have not partnered with the Department;
- A list of cities that are scheduled to partner with the Department during the upcoming calendar year;
- A list of cities that have declined to partner with the Department;
- An explanation of lessons learned and any process efficiencies incorporated by the Department;
- Any recommendations to further simplify the issuance and renewal of general business licenses by the Department; and
- Any other information the Department considers relevant.

There are 281 incorporated cities and towns in Washington, but only 226 issue local business licenses. Of those:

- As of December 31, 2021, 191 cities partner with the Department's Business Licensing Service (BLS);
- 10 cities participate with the FileLocal portal for local business and occupation (B&O) tax reporting and business licensing; and
- 25 cities are left to partner with BLS by December 31, 2022.

# **BLS Partnered Cities**

BLS is partnered with 191 cities as of December 31, 2021, reducing the license renewal workload for these cities and saving businesses time with a one-stop registration solution. (See Appendix A for a complete list of BLS partnered cities.)

In the January 2021 Local Business Licensing Partnership Plan, BLS was scheduled to partner with 38 cities in calendar year 2021. This was the third year of accelerated city onboarding. BLS met the planned goal, which required 8 to 12 cities per quarter to be onboarded.

## Cities Declined to Partner

As of January 1, 2022, ten cities that issue general business licenses participate in the FileLocal portal: Bellevue, Des Moines, Everett, Kent, Lake Forest Park, Renton, Seattle, Shoreline, Snoqualmie and Tacoma.

# **Lessons Learned and Process Efficiencies**

Process efficiencies were developed over the past year to enhance the partnership between BLS and local municipalities. The improvements include:

- Trainings, which are offered to existing partners on a quarterly basis and on an ad hoc
  basis. Quarterly trainings include refresher material based on frequently asked questions
  and include the most up-to-date information regarding system enhancements. Ad hoc
  trainings are conducted throughout the year and provide detailed guidance on the
  requested training subject.
- Revised webpages, which now include accordion dropdowns for each city's endorsement type. This display is more user friendly and visually appealing for customers, especially those using mobile or tablet devices.
- Enhanced city report capabilities to identify active businesses inside their city's limits that do not have a city license. This will provide accurate information on-demand and aid in reducing the compliance efforts of searching for non-compliant businesses within the city's limits.

## Recommendations

To further simplify the issuance and renewal of general business licenses, the Department recommends:

- We continue to onboard new partners by geographical location. The Department has been taking a geographical approach in building the city-partner schedule. The approach helps businesses, especially contractors, who engage in business in multiple nearby jurisdictions throughout the year. Onboarding neighboring cities will reduce confusion for business owners and aid in ensuring they are obtaining the necessary city licenses through a consolidated licensing process.
- We continue to add new licensing types and fee structures to expand BLS's suite of services offered.
- We add interactive training video modules for city staff, beyond the existing searching and navigating videos. Video content will include approving or denying a city license and generating reports, which are common questions fielded by BLS.

## **Relevant Information**

- The Department updated its core software in calendar year 2021. While this did not impact the progress of onboarding, the Department offered existing partners training sessions regarding the updates. Overall, 90% of attendees found this training both informative and useful.
- Enhancements made last calendar year to streamline and improve the process of partner training requests have proven effective, efficient and consistent in providing just in time training to partners.

## **NEXT STEPS**

Partnering Plan

The January 2022 Partnering Plan is the last required plan as all cities currently imposing a general business license will have partnered with the Department (or FileLocal) by December 31, 2022. A Plan is required "until the department has partnered with all cities that currently impose a general business license requirement" (RCW 35.90.020(4)(b)).

Annual Progress Report

By January 1, 2023, the Department will submit the annual progress report to the Legislature as required by RCW 35.90.020(8).
