Dear Senator Rivers and Representative Cody:

This report fulfills the requirements of RCW 18.225.800, which directs the Department of Health (department) to annually report, through 2020, the number of times mental health providers with an associate's license renew their credential four, five, and six times. We submitted our first report in October 2014.

Major Finding

The bottom line is that for state fiscal year 2017 (SFY 2017) 89 percent of those who obtained their "full" mental health provider licensure did so with four or fewer renewals of their associate license. Another 4 percent did so with five renewals and 7 percent with six renewals.

Background

The department began issuing associate licenses for these mental health professions in July 2009. At the time, an associate license could be renewed annually no more than four times. This meant associates had five years (initial associate licensure plus four annual renewals) to complete the additional education and supervisory requirements to apply for "full" licensure as a mental health counselor, marriage and family therapist, advanced social worker, or licensed independent clinical social worker.

In 2013, the legislature expanded the number of renewals allowed for an associate license from four to six (Chapter 73, Laws of 2013). At the same time, the department was directed to submit this annual report to help the legislature assess whether these expanded limits on associate licensure renewals remain adequate.

Data

Graph 1 and Table 1 represent the total number of people (licensees) during the fiscal year with an associate license and displays the number of times they have renewed their associate license under chapter 18.225 RCW. Table 1 gives additional detail by showing renewal information by each profession.

Graph 2 and Table 2 show data for those people (licensees) who achieved "full" licensure during the year and thus is a subset of the people in Graph 1 and Table 1.

The data show that the vast majority of people achieve "full" licensure (89 percent) with four or fewer renewals.




