In August 2016, the Public Works Board (Board) received 35 applications requesting more than \$110 million for construction loans.

Each application was reviewed to ensure it met threshold criteria.

5 projects failed threshold review:

- 4 projects were eligible for the Drinking Water State Revolving Loan Fund (DWSRF) Program. 43.155.070(14)(a) RCW prohibited projects from seeking Board funding if the project was eligible for either the DWSRF or the Clean Water State Revolving Loan Fund program.
- 1 project had been constructed at time of application.


Each project that passed threshold review was rated and ranked using a list of criteria outlined in Board statute - 43.155.070 RCW: (abbreviated list of considerations)

- Impacts to the health and safety of many people
- State funds leveraged
- Readiness to proceed to construction
- Project is located in an area of high unemployment
- Financial and environmental sustainability
- Equitable geographic awarding of funds
- Meeting of state policy objectives: job creation, economic development, transportation efficiencies, as well as public health and safety
- Other criteria the Board considers necessary to achieve the purposes of 43.155 RCW

In October 2016, the Board took action to approve funding for 25 projects totaling \$97.1 million.

\$97.1 million leverages *\$386 million* in federal and local infrastructure investments:

- \* Energy savings LED installations; reduced vehicle miles traveled; and improved staff time efficiencies.
- \* Environmental protection Fish passage restoration; improved bio-solids handling and disposal; solid waste clean-up and abatement.
- \* Public health and safety Repairing landslide damage; stormwater management in a floodplain; replacing high traffic bridges built in substandard soils.
- \* Economic development Revitalizing wildfire damaged communities; removing a transportation barrier in a successfully redeveloped mixed-use low vacancy area; and ensuring that an existing transportation corridor remains functional for its commercial, residential, and tribal traffic.
