In September 2023, WSDOT Local Programs awarded funds from the Reducing Rural Roadway Departures Program to eight projects in seven counties through the biennial County Safety Program call for projects.

RCW 47.04.410 (1) (e) requires the department provide a list of locations and a description of the safety improvements that received funding from the Reducing Rual Roadway Departures Program this year:

(e) By December 31st of each year when there is funding distributed in accordance with this program, the department must provide the transportation committees of the legislature and the traffic safety commission with a list of locations that received funding and a description of the safety improvements installed there.
