SHB 1355 Noxious Weed Assessment Report

Per Substitute House Bill 1355, 67th Legislature 2021 Regular Session, the Washington State Noxious Weed Control Board (WSNWCB) is tasked with reporting on the progress of this workgroup in the development and implementation of a system by which parcels owned or held by the department of transportation that have been declared to receive special benefit from the county noxious weed control board must be identified and all assessments may be effectively billed for payment according to the process in chapter 79.44 RCW.

Executive Summary

County noxious weed control board funding is derived from county general funds or by special noxious weed assessment. The process for establishing a county noxious weed assessment is described in RCW 17.10.240 1(c)(i). After a hearing, the county noxious weed board determines classifications of lands and noxious weed assessments per classification and then submits a proposed recommendation to the county legislative authority for the noxious weed assessment. The county legislative authority, after a hearing, then accepts or modifies by resolution all of or any portion of the proposed levels of noxious weed assessment. Previously there has been concern and confusion about how this assessment is billed to WSDOT. This workgroup was assigned to develop a system by which county noxious weed assessments for parcels are to be billed to WSDOT, per SHB 1355.

The main goals of this workgroup are to:

- Identify the needs of WSDOT, County Assessors, County Treasurers, and Noxious Weed Programs pertaining to the noxious weed assessment billing process.
- Establish a system for submitting statements of noxious weed assessment billings to WSDOT (Appendix A).
- Identify solutions to update DOT data.
- Identify obstacles or barriers to successfully develop a system by which to bill WSDOT electronically for the noxious weed assessment.

WSDOT Requests

WSDOT has requested that billings for noxious weed assessments be submitted with electronic statements. These statements can be in a simple excel spreadsheet format containing the following fields: parcel #, acreage or size of lot, amount of assessment. WSDOT can then use this information to validate the parcels charged the noxious weed assessment against their own records. This was discussed in detail throughout the workgroup meetings. RCW 17.10.240 clearly outlines the process by which the noxious weed assessment is to be established at the county level. Once the rates are established, following RCW 17.10.240, WSDOT shall be billed electronically. The determination of which agency, i.e. county weed board, assessor or treasurer, will provide the electronic document will be determined at the county level. The County Treasurer will continue to comply with RCW 84.56.020(2).

Local County Limitations

This group identified obstacles at the county level. Some counties may not have the proper or compatible software to export such spreadsheet files and documents. Also, departments at the county level may lack funding and resources to contribute time to developing new systems or processes by which to bill WSDOT electronically separate from their other assessment billings. It should be determined at the local county level which department, either the Assessor or Noxious Weed Control Board based on resource available, will take on the role of determining which WSDOT parcels are to be assessed, if any, for the noxious weed assessment based on land classifications. Each county is unique and departments are encouraged to work together to develop a system to meet the county's individual needs. WSDOT and the WSNWCB will work in continued collaboration with each county as they undergo the development of their own system and/or protocols.

There was some discussion about the definition of centerline miles and how to calculate the noxious weed assessment for right of ways. WSDOT suggested using the following assumptions for centerline miles based on road type:

"For consistency and ease of calculating assessment rates, we would like to propose the counties all use the assumption of 1 mile = 1 parcel, and that we have two width categories to determine acres per mile – the average width for any secondary/local distributor roads is **60 ft. width** and freeways/divided highways use an average width of **120 ft. width**."

WSDOT also provided an updated excel workbook with the centerline miles that they have recorded for each county (not included in this report). After discussion with county noxious weed coordinators and this group, once again the formula for calculating the noxious weed assessment will be determined at the local level based on assessment amount and road type. The WSDOT suggested assumptions that may be taken into consideration. RCW 17.10.010 (5) states "Centerline miles" means the length of any given road right-of-way corridor in miles, along the center line of the overall roadway alignment." The language in RCW 17.10.240 (c)(i) states "...or, for rights-of-way, a rate based on centerline miles..." The above assumptions are only suggested as a way to covert assessment rates to centerline miles. The intention is not to add width to the definition in RCW 17.10.010(5). This was suggested to insure that the assessment on right of ways is fair and equitable and comparable to surrounding parcel assessments. Local county noxious weed boards may suggest alternative means for assessing right of ways. The Treasurers provided a very simplistic billing method that reduced the workload of the Assessor's office and Noxious Weed Board (please see example in appendix B). There is no need to create new parcels and parcels that existed that included road right of way would be deleted in this proposed Treasurers' process. The DOT may make a distinction on their data of different types of roads but the Noxious Weed Board (with the approval of the County Commissioners) still has final determination for the rate per mile they want to assess. The billing can be similar to the PILT like billing that Treasurers or Assessors do for the Fish and Wildlife parcels each year. statement. Weed Districts may also be empowered to set a rate(s) per mile on DOT road right of way within their boundaries.

It was also determined that the data to update DOT records was not needed to be part of the annual tax statement being mailed out. The data DOT wishes can be given to DOT separately from the billing process and done much earlier in the prior year.

Conclusion

This workgroup shared examples of assessment statements along with WSDOT spreadsheets of types of parcels, roads, and holdings WSDOT owns and manages (Please see Appendix B). Overall, this was a very cooperative and positive group in identifying obstacles and solutions. Such obstacles included software limitations, resource availability, and discrepancies of records between counties and WSDOT. Solutions include establishing an electronic submission to WSDOT for the noxious weed assessment using very basic software. This again allows for validation by both the county and WSDOT, continued accuracy, and ease of updating any changes.

The WSNWCB will contact noxious weed coordinators in counties with noxious weed assessments providing a breakdown of the assessment process and examples of noxious weed assessment statements for WSDOT. The WSNWCB will offer support to the best of its ability. Moving forward, the WSNWCB will facilitate additional meetings, as issues arise. Appendix A

Draft Example Protocol for Noxious Weed Assessment Billing to WSDOT

- I. County Establishes Noxious Weed Assessment (RCW 17.10.240)
 - A. County Noxious Weed Board, after a hearing, submits proposal of land classifications and noxious weed assessments based on those classification to county legislative authority.
 - B. County legislative authority, after a hearing, shall accept or modify by resolution all or part of the proposed levels of assessment.
- II. WSDOT Parcels Identified for Noxious Weed Assessment and Billing.
 - A. The County Assessor or Noxious Weed Control Board identifies WSDOT parcels, if any, to be assessed for the noxious weed assessment based on land classification. The department assigned to this role shall be determined at the local county level depending on resources available. Or:
 - B. Based on the detailed centerline data DOT provides, each year (deadline not discussed of when for this) for each road segment, the Noxious Weed Control Board provides the mile type, rate(s) and dollar amount to the County Treasurer or Assessor to create a PILT like bill to send with the tax statement(s) of other parcels that are not road right of ways.
 - C. Electronic information on parcels should include the following fields when applicable. This information may be submitted with assessment billings or at a different time to help insure accuracy in the data.
 - 1. Fields to be included:
 - a. Parcel #
 - b. Acres/Lot size
 - c. Assessment Amount
 - d. Additional fields can be included such as: Assessment Rate, Township/Range, and any other information
 - D. Statement is submitted to County Treasurer for billing to WSDOT.
 - 1. County Treasurer finalizes billing statement as submitted (electronic spreadsheet may be provided by either noxious weed control board, assessor, or treasure depending on county agency abilities) and submits it to WSDOT.
