Project Description from 16LEGFIN:

To address traffic congestion, safety and the need for pedestrian facilities from SR 106 to NE Belfair Street, these roadway improvements include the continuation of the existing two-way left turn lane from the vicinity of the intersection of SR 3 and Romance Hill Road to the intersection of SR 3 and SR 106. Other improvements include pedestrian and bicycle facilities, storm sewer improvements and mitigation requirements. When complete, this project will relieve congestion and enhance motorist safety.

Justification of Need:

1. What is the requested change to this project?

Increase 2015-17 biennium planned TPA expenditures by \$950,000. This also represents a total project cost increase of that amount and a 9-month delay of the project completion date.
