


#### **WE ARE UNIQUE**

We are **inclusive**. We work with other groups, organizations, and local & state agencies to find solutions that work for most.




We believe in **sustainable** strategies that take into account people and the planet, as well as profits.

#### OUR MEMBERS REPRESENT THE FULL SPECTRUM OF THE INDUSTRY




#### OUR MEMBERS REPRESENT EVERY LICENSE TYPE



## **TAXATION**

#### **Industry Taxation/Access to Banking**

- IRS 280E, coupled with WA state having the highest excise tax, is crippling to small businesses and prevents
   Washington from being competitively positioned for the National and Global Marketplace
- No typical business write-offs
- Banks will not lend traditionally
  - No business lines of credit
  - No SBA loans
  - Usury rates


## **TAXATION SOLUTIONS**

- Legislature appropriate moneys in the dedicated marijuana account to provide loans for cannabis businesses.
  - Also a good opportunity for social equity grants and loans.
- Allow producers and processors to sell products with
  - < .3% THC to the open market
    - This will also cut down on waste, increasing sustainability
- Allow retailers to sell non-cannabis items
  - They'll be able to write off non-cannabis items,
    advertising, office work, etc like a "normal" business

## **TRACEABILITY SOLUTIONS**

- Audit Based System (like DFI)
  - The industry should not be reliant on a government agency to be able to conduct business as normal





# **SAFE CONSUMPTION**

- Testing of Pesticides and Heavy Metals
  - Washington State is the only state that does not require pesticide testing on adult use products
- Consumer safety
  - Where can consumers get accurate information?
- Ability to consume safely and legally



## **SAFE CONSUMPTION SOLUTIONS**

- Implement mandatory pesticide testing of end products
- Require "NOT TESTED FOR PESTICIDES" on products that do not have pesticide tests
- Use the current WSDA contract to pesticide test the largest volume concentrate companies
- Fund more health research and education
- Consider establishing safe consumption sites



### **MEDICAL ACCESS / PATIENTS**

- Lack of medical products on the shelves
  - Lack of pesticide and heavy metal tested products
- Extreme cost increase after SB 5052
  - Patients pay 37% excise tax
- Unreliable information at point of sale
- Not HIPPA compliant
- Poor consultation environment

## MEDICAL ACCESS SOLUTIONS

- Remove excise tax for qualified patients
- Provide incentive for:
  - retailers to carry medical product
  - producer/processors to grow medical product
- Allow qualified patients to purchase more than current limit
- Effectively train budtenders/consultants
  - EDUCATION
- Medical professional provides card; not the retailer.



## **RESEARCH / BEST PRACTICES**

- Cannabis is undeniably the most under-researched commodity in the United States, with a great need for science based research and education
- Lack of access to shared, trusted, and verified resources and information on safe growing methods
- Lack of cannabis-related education and training including health and safety information for producers



## **CANNABIS COMMISSION SOLUTION**

- Support the establishment of the Cannabis Commission through the legislature
- Research plant development and safe cultivation techniques
- Washington should lead the way in cannabis research
- Owned by all farmers, benefitting large and small businesses
- Provides much needed education and resources for cannabis farmers
- Establishes best practices
- Encourages plant diversity for further research
