LCB Response to Covid-19

- Governor Issues Stay Home, Stay Healthy Directive
 - March 2020
- Immediately prepared an Incident Management Team made up of Management Team and Board Chair
 - This team met first thing daily to make critical decisions
 - Team determined that most LCB staff could adequately continue serving licensees while working remotely.
 - Sent staff home with basics following Governor's directive

LCB Response to Covid-19

External Communications

- Created website to communicate agency decisions and how to get help
- Issued regular messages licensees via GovDelivery

Enforcement

- Established protocols for driving alone in vehicles
- Suspended compliance checks with minors

Licensing

- Immediately beefed up customer service
- Staff set up a new email account and triaging to answering initial onslaught of questions from licensees using a single email address

- Licensees that Sell Alcohol
 - Among the hardest hit of all financial sectors
 - Hospitality and leisure sector down 63 percent since March (Dept. of Commerce dashboard)
- LCB Communication and Organization
 - Direct communication with licensees (throughout)
 - Immediately formed Legal and Policy Team
 - Board chair, agency leadership, key staff
 - Met daily to make immediate allowances for industries
 - Top priority was public safety then help for struggling industries
 - Executive, Licensing and Enforcement
 - Met regularly with Governor's Office and trade organizations to provide flexibility and subsequently, income.
 - Currently working with 19 cities to seek ways to allow outdoor seating and shared space
 - Met last week with Tacoma Mayor, Governors' Office restaurants and trade groups to keep business during down months

- Creative Allowances for Liquor Licensees (Over 125 liquor issues)
 - All licensees
 - Emergency Board actions to allow for late payments without penalties and other rule changes
 - Restaurants
 - Initially cocktail kits but later moved to mixed cocktails to go with sales of food
 - Opened up delivery services for beer and wine
 - Opened up bar seating for minors to allow for additional space
 - Sped up process for approving outdoor alcohol service


Distilleries

- Allowed distillers to make sanitizer
- Nightclubs, Breweries, Wineries, Distilleries and Taverns
 - Helped wineries, distillers, taverns and breweries that don't serve food quickly transition to a license where they could stay open.

Creative Allowances (continued)

- Farmers Markets
 - Relaxed food service requirements at farmer's markets associated with sampling
- St. Patrick's Day Inventory
 - Created opportunities for taverns, nightclubs, etc. that built up for St. Patrick's Day sales to return product for refund
- Trucking services for liquor licensed distributors
 - Temporary allowance to permit licensed distributors, and other industry members, to sell trucking and distribution services for non-liquor items to licensed retailers

COVID-19 Impact

- Temporary allowances for outside service
- Collaboration with local cities and counties
- Reallocated resources to expedite requests

Cannabis Industry Remained Open

- Governor listed cannabis retailers as "essential" due to stores being only place to legally acquire the product.
- Cannabis producers/processors essential because they supply/support retailers.
- Unlike alcohol licensees, all remained open throughout

Allowances for Cannabis Industry

- Allowing kids under age 16 on producer farms (child care needs, often on remote farms)
- Curbside service
- Relaxed timelines related to maximum delivery times due to wildfires

Current Status with Covid Restrictions


Allowances

- Highly received by licensees, govt. leaders of Seattle, Tacoma and Spokane, and hospitality industry
- Prevention community and law enforcement have expressed concerns
- Policy and Rules Unit analyzing all allowances and developing recommendations for amending where appropriate
- Slated to expire within 30 days of county entering Phase 4

LCB Employees and Public

- Communicated that we're teleworking through 2020
- Incident Management Team meets twice weekly to address staff issues
 - How to support staff at home
 - Engaging staff about their well being during Covid, fires, and current issues
- Legal and Policy meets twice per week to address emerging issues

Covid-19 Restrictions and LCB Response

- Cannabis business were not required to close
- Several health-related issues emerged
 - Protecting health of employees
 - Health risks for customers
- Licensees revised operational procedures
 - Mask wearing
 - Social distancing
 - Hand sanitizing
 - Handling of products, menus

Agency Policy Responses

- Closure of schools and child care facilities/programs
 - LCB guidance allowing minors on location at production facilities
 - Guardrails: Under 16 years of age only; no work activity allowed; time limited
- Curbside service
 - LCB re-interpreted requirements for transactions on premises; premises include retail store's parking lot


Supporting Cannabis Licensee Success

- Full implementation of ESHB 5318, Part One
 - Extensive collaboration with industry, licensees and others to completely redesign and co-construct marijuana penalty rule structure.
 - Established process for issuance of Notice of Correction as opposed to civil penalty
 - Reduced cumulative effect of escalating penalties to two years
 - Added a deferral option for first-time offences
 - Restructured penalty grids and established categories based on violation severity
 - Collaborative rule development process resulted in one affirmative comment at hearing, and one comment from public health.
 - Rules adopted January 22, 2020


Supporting Cannabis Licensee Success

- Full implementation of ESHB 5318, Part Two
 - Collaborated with industry representatives, licensees and others to co-design a voluntary consultation and education program.
 - Rules frame frequency, manner and method for provision of consultative and educational services designed to support licensee success.
 - Extensive collaborative rule development resulted in no written or oral comment at public hearing.
 - Final rules will be presented to the Board for adoption on September 30, 2020

The agency has had a change in emphases since the outbreak of COVID 19. Education given to businesses on the changes to rules due to COVID 19 has required more officer capacity. Educational hours have increased while other areas officer actions have decreased.

Marijuana Excise Tax

Background

- Tax is paid the 20th of the month following the actual sales
 - The month listed reflects the excise tax collected from the previous month's sales. For example, April collections reflect March's sales.
 - Highlighted cells are the months of Stay Home, Stay Healthy


Analysis

- Strong cannabis sales growth continues year over year
- Covid months' collections far exceed growth of non-Covid months
- FY20 August collections (for July sales) topped \$50 million for the first time ever and were 41% higher than August FY19.
- Total Excise Tax collected since first sales in July 2014: \$1.2 billion



Implementing Cannabis Legislation: Social Equity

- LCB Board Members identified three priorities in 2019
 - Social Equity, medical market viability and small producer sustainability
- Agency-request legislation social equity proposed by LCB
 - HB 2870 by Rep. Eric Pettigrew
 - Companion SB 6604 Prime Sponsored by Sen. Keiser
 - Co-sponsored by Sens. Conway, Saldana, Hasegawa and others

Purpose of E2SHB 2870

- Reduce barriers to entry into cannabis industry for those most adversely impacted by cannabis prohibition enforcement
- Disproportionate Impact well documented
 - Nationwide, African Americans arrested at four times the rate of White Americans, despite similar usage rates
 - In Washington, Latino and Native American residents arrested for marijuana possession 1.6 times more often than White residents from 2000 to 2010
 - Even after passage of I-502, African Americans in
 Washington arrested at twice the rate of White residents.

Key Elements

- Cannabis retail licenses forfeited, revoked, cancelled or never issued will become available
 - Approximately 34 licenses
- Legislative Task Force on Social Equity in Marijuana created
 - Guide the LCB in development of program details
 - Recommendations on potential future development of the program
- Pandemic has delayed launch of Task Force work
- Lt. Gov. and House Speaker appointed 17 members
- Task force plans to hold their initial meeting in the coming weeks

LCB Assisting Task Force

- Governor's Interagency Council on Health Disparities provides
 Task Force staff support
- LCB assisting Task Force staff as requested
- LCB posting information on website with periodic implementation updates
- LCB organizing community outreach meetings (Sept. 29, Oct. 5 and 12)
