PROPOSED SUBSTITUTE HOUSE BILL

Original bill: 1236

Substitute bill compared to original bill:

- The definition of "subsidized housing" is changed to include "rental housing for very low-income or low-income households that is a dwelling unit operated directly by a public housing authority or its affiliate."
- Provides that the landlord may not terminate a tenancy for a specified time except for enumerated causes, and, when the specified time expires, the tenancy becomes a monthly periodic tenancy except for when it is an initial term of one year and the landlord provides 60 days' prior written notice.
- Provides that the tenant may terminate a tenancy for a specified time by providing 20 days' prior written notice.
- The cause for eviction or termination of tenancy due to unpaid rent is amended so that, if the tenant's unpaid rent accrues between March 1, 2020 and the end of a declared public health emergency related to COVID-19, the landlord must offer a repayment schedule that does not exceed monthly payments equal to one-third of the monthly rent.
- · In the cause for terminating a tenancy when an owner "elects to sell" a residence, references to listing the residence for sale in a newspaper of general circulation are changed to listing the residence on the real estate multiple listing service.
- The landlord may end a tenancy where the tenant lives in subsidized housing and the rental agreement expires without the tenant signing a new rental agreement proffered by the landlord, provided that the landlord proffered the new rental agreement at least 30 days and no more than 90 days prior to expiration of the rental agreement.
- Where a tenant has permanently vacated for reasons other than termination by the landlord, and occupants co-resided with the tenant prior to and up to the tenant's vacation with the landlord's approval, the tenant must apply or reapply as a prospective tenant within 90 days of when the primary tenant vacates, instead of "immediately."
- · All written notices must identify the facts and circumstances known and available to the landlord at the time of the issuance of the notice.
- A provision is added to RCW 59.18.220 providing that, except as limited by this act, in cases where premises are rented for a specified time, the tenancy will be deemed terminated at the end of such specified time upon sufficient notice.

AN ACT Relating to protecting residential tenants from the beginning to end of their tenancies by penalizing the inclusion of unlawful lease provisions and limiting the reasons for eviction, refusal to continue, and termination; amending RCW 59.18.220 and 59.12.030; reenacting and amending RCW 59.18.030, 59.18.200, and 59.18.230; adding a new section to chapter 59.18 RCW; prescribing penalties; and declaring an emergency.

- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 9 **Sec. 1.** RCW 59.18.030 and 2019 c 356 s 5, 2019 c 232 s 24, and 10 2019 c 23 s 1 are each reenacted and amended to read as follows:
- 11 As used in this chapter:
- 12 (1) "Active duty" means service authorized by the president of 13 the United States, the secretary of defense, or the governor for a 14 period of more than ((thirty)) 30 consecutive days.
- (2) "Certificate of inspection" means an unsworn statement, 15 16 declaration, verification, or certificate made in accordance with the 17 requirements of chapter 5.50 RCW by a qualified inspector that states 18 the landlord has not failed to fulfill any substantial 19 obligation imposed under RCW 59.18.060 that endangers or impairs the 20 health or safety of a tenant, including (a) structural members that are of insufficient size or strength to carry imposed loads with 21 Code Rev/AI:akl 1 H-0791.1/21

safety, (b) exposure of the occupants to the weather, (c) plumbing and sanitation defects that directly expose the occupants to the risk of illness or injury, (d) not providing facilities adequate to supply heat and water and hot water as reasonably required by the tenant, (e) providing heating or ventilation systems that are not functional or are hazardous, (f) defective, hazardous, or missing electrical wiring or electrical service, (g) defective or hazardous exits that increase the risk of injury to occupants, and (h) conditions that increase the risk of fire.

- (3) "Commercially reasonable manner," with respect to a sale of a deceased tenant's personal property, means a sale where every aspect of the sale, including the method, manner, time, place, and other terms, must be commercially reasonable. If commercially reasonable, a landlord may sell the tenant's property by public or private proceedings, by one or more contracts, as a unit or in parcels, and at any time and place and on any terms.
- (4) "Comprehensive reusable tenant screening report" means a tenant screening report prepared by a consumer reporting agency at the direction of and paid for by the prospective tenant and made available directly to a prospective landlord at no charge, which contains all of the following: (a) A consumer credit report prepared by a consumer reporting agency within the past ((thirty)) 30 days; (b) the prospective tenant's criminal history; (c) the prospective tenant's eviction history; (d) an employment verification; and (e) the prospective tenant's address and rental history.
- (5) "Criminal history" means a report containing or summarizing (a) the prospective tenant's criminal convictions and pending cases, the final disposition of which antedates the report by no more than seven years, and (b) the results of a sex offender registry and United States department of the treasury's office of foreign assets control search, all based on at least seven years of address history and alias information provided by the prospective tenant or available in the consumer credit report.
- 34 (6) "Designated person" means a person designated by the tenant 35 under RCW 59.18.590.
 - (7) "Distressed home" has the same meaning as in RCW 61.34.020.
- 37 (8) "Distressed home conveyance" has the same meaning as in RCW 38 61.34.020.
- 39 (9) "Distressed home purchaser" has the same meaning as in RCW 40 61.34.020.

- 1 (10) "Dwelling unit" is a structure or that part of a structure 2 which is used as a home, residence, or sleeping place by one person 3 or by two or more persons maintaining a common household, including 4 but not limited to single-family residences and units of multiplexes, 5 apartment buildings, and mobile homes.
 - (11) "Eviction history" means a report containing or summarizing the contents of any records of unlawful detainer actions concerning the prospective tenant that are reportable in accordance with state law, are lawful for landlords to consider, and are obtained after a search based on at least seven years of address history and alias information provided by the prospective tenant or available in the consumer credit report.
- 13 (12) "Gang" means a group that: (a) Consists of three or more 14 persons; (b) has identifiable leadership or an identifiable name, 15 sign, or symbol; and (c) on an ongoing basis, regularly conspires and 16 acts in concert mainly for criminal purposes.
- 17 (13) "Gang-related activity" means any activity that occurs 18 within the gang or advances a gang purpose.
 - (14) "In danger of foreclosure" means any of the following:

- 30 (ii) A person licensed or required to be licensed under chapter 31 19.134 RCW;

- 36 (v) An attorney-at-law;

- (16) "Mortgage" is used in the general sense and includes all instruments, including deeds of trust, that are used to secure an obligation by an interest in real property.
- (17) "Orders" means written official military orders, or any written notification, certification, or verification from the service member's commanding officer, with respect to the service member's current or future military status.
- 13 (18) "Owner" means one or more persons, jointly or severally, in whom is vested:
 - (a) All or any part of the legal title to property; or

 - (23) "Prospective landlord" means a landlord or a person who advertises, solicits, offers, or otherwise holds a dwelling unit out as available for rent.
- 36 (24) "Prospective tenant" means a tenant or a person who has 37 applied for residential housing that is governed under this chapter.
- 38 (25) "Qualified inspector" means a United States department of 39 housing and urban development certified inspector; a Washington state 40 licensed home inspector; an American society of home inspectors Code Rev/AI:akl 4 H-0791.1/21

certified inspector; a private inspector certified by the national association of housing and redevelopment officials, the American association of code enforcement, or other comparable professional association as approved by the local municipality; a municipal code enforcement officer; a Washington licensed structural engineer; or a Washington licensed architect.

- (26) "Reasonable attorneys' fees," where authorized in this chapter, means an amount to be determined including the following factors: The time and labor required, the novelty and difficulty of the questions involved, the skill requisite to perform the legal service properly, the fee customarily charged in the locality for similar legal services, the amount involved and the results obtained, and the experience, reputation and ability of the lawyer or lawyers performing the services.
- (27) "Reasonable manner," with respect to disposing of a deceased tenant's personal property, means to dispose of the property by donation to a not-for-profit charitable organization, by removal of the property by a trash hauler or recycler, or by any other method that is reasonable under the circumstances.
- (28) "Rent" or "rental amount" means recurring and periodic charges identified in the rental agreement for the use and occupancy of the premises, which may include charges for utilities. Except as provided in RCW 59.18.283(3), these terms do not include nonrecurring charges for costs incurred due to late payment, damages, deposits, legal costs, or other fees, including attorneys' fees.
- (29) "Rental agreement" means all agreements which establish or modify the terms, conditions, rules, regulations, or any other provisions concerning the use and occupancy of a dwelling unit.
- (30) "Service member" means an active member of the United States armed forces, a member of a military reserve component, or a member of the national guard who is either stationed in or a resident of Washington state.
- (31) A "single-family residence" is a structure maintained and used as a single dwelling unit. Notwithstanding that a dwelling unit shares one or more walls with another dwelling unit, it shall be deemed a single-family residence if it has direct access to a street and shares neither heating facilities nor hot water equipment, nor any other essential facility or service, with any other dwelling unit.

- 1 (32) A "tenant" is any person who is entitled to occupy a 2 dwelling unit primarily for living or dwelling purposes under a 3 rental agreement.

- (a) A personal representative of a deceased tenant's estate if known to the landlord;
- (b) If the landlord has no knowledge that a personal representative has been appointed for the deceased tenant's estate, a person claiming to be a successor of the deceased tenant who has provided the landlord with proof of death and an affidavit made by the person that meets the requirements of RCW 11.62.010(2);
- (c) In the absence of a personal representative under (a) of this subsection or a person claiming to be a successor under (b) of this subsection, a designated person; or
- (d) In the absence of a personal representative under (a) of this subsection, a person claiming to be a successor under (b) of this subsection, or a designated person under (c) of this subsection, any person who provides the landlord with reasonable evidence that he or she is a successor of the deceased tenant as defined in RCW 11.62.005. - 29 (36) "Immediate family" includes state registered domestic 30 partner, spouse, parents, grandparents, children, including foster 31 children, siblings, and in-laws.
- 32 (37) "Subsidized housing" refers to rental housing for very low-33 income or low-income households that is a dwelling unit operated 34 directly by a public housing authority or its affiliate, or that is 35 insured, financed, or assisted in whole or in part through one of the 36 following sources:

- (c) An affordable housing levy authorized under RCW 84.52.105; or
- (d) The surcharges authorized by RCW 36.22.178 and 36.22.179 and any of the surcharges authorized in chapter 43.185C RCW.
- 6 (38) "Transitional housing" means housing units owned, operated, 7 or managed by a nonprofit organization or governmental entity in which supportive services are provided to individuals and families 8 that were formerly homeless, with the intent to stabilize them and 9 move them to permanent housing within a period of not more than 10 twenty-four months, or longer if the program is limited to tenants 11 12 within a specified age range or the program is intended for tenants in need of time to complete and transition from educational or 13 14 training or service programs.
- NEW SECTION. Sec. 2. A new section is added to chapter 59.18 RCW to read as follows:
 - (1) (a) A landlord may not evict a tenant, refuse to continue the tenancy, or terminate a periodic tenancy except for the causes enumerated in subsection (2) of this section.
 - (b) Provided that the initial term of the tenancy is for a specified time of one year, a landlord may terminate the tenancy without cause at the end of the first year of the tenancy upon 60 days' prior written notice, served in a manner consistent with RCW 59.12.040. If a landlord does not give 60 days' notice as provided in this subsection, the tenancy becomes a monthly periodic tenancy until further agreement of the landlord and tenant, which can only be terminated for the reasons listed as cause enumerated in subsection (2) of this section.
 - (c) Except as provided in (b) of this subsection, a landlord may not terminate a tenancy for a specified time except for the causes enumerated in subsection (2) of this section. Upon the end date of the specified time, the tenancy becomes a monthly periodic tenancy. Nothing prohibits a landlord and tenant from entering into subsequent lease agreements that are in compliance with the termination requirements in subsection (2) of this section.
- 36 (d) A tenant may terminate a tenancy for a specified time by 37 providing notice in writing not less than 20 days prior to the ending 38 date of the specified time.

- (a) The tenant continues in possession in person or by subtenant after a default in the payment of rent, and after written notice requiring, in the alternative, the payment of the rent or the surrender of the detained premises has remained uncomplied with for the period set forth in RCW 59.12.030(3) for tenants subject to this chapter. The written notice may be served at any time after the rent becomes due, provided the unpaid rent did not accrue between March 1, 2020, and the end of a declared federal or state public health emergency related to the COVID-19 pandemic. If the tenant accrues unpaid rent between March 1, 2020, and the end of a declared federal or state public health emergency related to the COVID-19 pandemic, the landlord shall have offered a reasonable schedule for the repayment of unpaid rent that does not exceed monthly payments equal to one-third of the monthly rental charges during the period of accrued debt. If a tenant fails to accept the terms of a reasonable repayment plan within 14 days of the landlord's offer or defaults on any rent owed under a repayment plan, the landlord may proceed with an unlawful detainer action as set forth in RCW 59.12.030(3). The court shall consider the tenant's circumstances, including decreased income or increased expenses due to COVID-19, and the repayment plan terms offered during any unlawful detainer proceeding;
 - (b) The tenant continues in possession after substantial breach of a material program requirement of subsidized housing, material term subscribed to by the tenant within the lease or rental agreement, or a tenant obligation imposed by law, other than one for monetary damages, and after the landlord has served written notice specifying the acts or omissions constituting the breach and requiring, in the alternative, that the breach be remedied or the rental agreement will terminate, and the breach has not been adequately remedied by the date specified in the notice, which date shall be at least 10 days after service of the notice;
 - (c) The tenant continues in possession after having received at least three days' written notice to quit after he or she commits or permits waste or nuisance upon the premises, unlawful activity that affects the use and enjoyment of the premises, or other substantial or repeated and unreasonable interference with the use and enjoyment of the premises by the landlord or neighbors of the tenant;

(d) The tenant continues in possession after the landlord of a dwelling unit in good faith seeks possession so that the owner or his or her immediate family may occupy the unit as that person's principal residence and no substantially equivalent unit is vacant and available to house the owner or his or her immediate family in the same building, and the owner has given at least 90 days' advance written notice of the date the tenant's possession is to end. There is a rebuttable presumption that the owner did not act in good faith if the owner or immediate family fails to occupy the unit as a principal residence for at least 60 consecutive days during the 90 days immediately after the tenant vacated the unit pursuant to a notice of termination using this subsection (2)(d) as the cause for termination;

- (e) The tenant continues in possession after the landlord elects to sell a single family residence and the landlord has given at least 90 days' advance written notice of the date the tenant's possession is to end. For the purposes of this subsection (2)(e), an owner "elects to sell" when the owner makes reasonable attempts to sell the dwelling within 30 days after the tenant has vacated, including, at a minimum, listing it for sale at a reasonable price with a realty agency or advertising it for sale at a reasonable price by listing it on the real estate multiple listing service. There shall be a rebuttable presumption that the owner did not intend to sell the unit if:
- (i) Within 30 days after the tenant has vacated, the owner does not list the single-family dwelling unit for sale at a reasonable price with a realty agency or advertise it for sale at a reasonable price by listing it on the real estate multiple listing service; or
- (ii) Within 90 days after the date the tenant vacated or the date the property was listed for sale, whichever is later, the owner withdraws the rental unit from the market, rents the unit to someone other than the former tenant, or otherwise indicates that the owner does not intend to sell the unit;
- (f) The tenant continues in possession of the premises after the landlord serves the tenant with advance written notice pursuant to RCW 59.18.200(2)(c);
- 37 (g) The tenant continues in possession after the owner elects to 38 withdraw the premises to pursue a conversion pursuant to RCW 39 64.34.440 or 64.90.655;

(h) The tenant continues in possession, after the landlord has served 30 days' advance written notice that: (i) The premises has been certified or condemned as uninhabitable by a local agency charged with the authority to issue such an order; and (ii) continued habitation of the premises would subject the landlord to civil or criminal penalties. However, if the terms of the local agency's order do not allow the landlord to provide 30 days' advance written notice, the landlord shall provide as much advance written notice as is possible and still comply with the order;

- (i) The tenant continues in possession after an owner or lessor, with whom the tenant shares the dwelling unit or access to a common kitchen or bathroom area, has served a 20-day notice to quit or vacate prior to the end of the rental term or, if a periodic tenancy, the end of the rental period;
- (j) The tenant continues in possession of a dwelling unit in transitional housing after having received a 30-day notice to vacate in advance of the expiration of the program, the tenant has aged out of the program, or the tenant has completed an educational or training or service program and is no longer eligible to participate. Nothing in this subsection (2)(j) shall be construed to prohibit the termination of a tenancy in transitional housing for any of the other causes specified in this subsection;
- (k) In cases where the tenant resides in subsidized housing, the tenant continues in possession after the expiration of a rental agreement without signing a proposed new rental agreement proffered by the landlord; provided, that the landlord proffered the proposed new rental agreement at least 30 days and no more than 90 days prior to the expiration of the current rental agreement and that any new terms and conditions of the proposed new rental agreement are reasonable. This subsection (2)(k) shall not apply to tenants whose tenancies are or have become periodic;
- (1) (i) The tenant continues in possession after having received a 30-day notice to quit due to intentional, knowing, and material misrepresentations or omissions made on the tenant's application at the inception of the tenancy that, had these misrepresentations or omissions not been made, would have resulted in the landlord requesting additional information or taking an adverse action. Except as provided in (1)(ii) of this subsection, the 30-day notice must be served on the tenant within the first 60 days of the initiation of the tenancy;

(ii) The landlord may seek termination under this subsection (2)(1) at any time during the tenancy if the misrepresentation makes the tenant ineligible for subsidized housing as defined in this chapter.

- (3) (a) Where a tenant has permanently vacated due to voluntary or 5 6 involuntary events, other than by termination by the landlord, any remaining occupants who had coresided with the tenant prior to and up 7 to the time the tenant permanently vacated must immediately apply or 8 reapply as a prospective tenant in order to continue to reside in the 9 dwelling unit and must meet the same screening, background, and 10 11 financial criteria as would any other prospective tenant in order to continue the tenancy on the same terms and conditions as the vacating 12 tenant. In the event that the occupant fails to apply within 90 days 13 of when the primary tenant vacates or the application is denied for 14 failure to meet the criteria, the landlord may commence an unlawful 15 16 detainer action under this chapter. - Sec. 3. RCW 59.18.200 and 2019 c 339 s 1 and 2019 c 23 s 2 are each reenacted and amended to read as follows:
- (1) (a) When premises are rented for an indefinite time, with monthly or other periodic rent reserved, such tenancy shall be construed to be a tenancy from month to month, or from period to period on which rent is payable, and shall be terminated by written notice of ((twenty)) 20 days or more, preceding the end of any of the months or periods of tenancy, given by ((either party)) the tenant to the ((other)) landlord.
- (b) Any tenant who is a member of the armed forces, including the national guard and armed forces reserves, or that tenant's spouse or dependent, may terminate a rental agreement with less than ((twenty)) 20 days' written notice if the tenant receives permanent change of station or deployment orders that do not allow a ((twenty)) 20-day written notice.
- (2) (a) Whenever a landlord plans to change to a policy of excluding children, the landlord shall give a written notice to a tenant at least ((ninety)) 90 days before termination of the tenancy to effectuate such change in policy. Such ((ninety)) 90-day notice shall be in lieu of the notice required by subsection (1) of this section. However, if after giving the ((ninety)) 90-day notice the change in policy is delayed, the notice requirements of subsection (1) of this section shall apply unless waived by the tenant.
- (b) Whenever a landlord plans to change any apartment or apartments to a condominium form of ownership, the landlord shall provide a written notice to a tenant at least ((one hundred twenty)) 120 days before termination of the tenancy, in compliance with RCW 64.34.440(1), to effectuate such change. The ((one hundred twenty-day)) 120-day notice is in lieu of the notice required in subsection (1) of this section. However, if after providing the ((one hundred twenty-day)) 120-day notice the change to a condominium form of ownership is delayed, the notice requirements in subsection (1) of this section apply unless waived by the tenant.

- (C) "Demolish" means the destruction of premises or the relocation of premises to another site that results in the displacement of an existing tenant.
 - (D) "Substantially rehabilitate" means extensive structural repair or extensive remodeling of premises that requires a permit such as a building, electrical, plumbing, or mechanical permit, and that results in the displacement of an existing tenant.
 - (3) A person in violation of subsection (2)(c)(i) of this section may be held liable in a civil action up to three times the monthly rent of the real property at issue. The prevailing ((party)) tenant may also recover court costs and reasonable attorneys' fees.

- (a) Agrees to waive or to forgo rights or remedies under this chapter; or
- (b) Authorizes any person to confess judgment on a claim arising out of the rental agreement; or
- (c) Agrees to pay the landlord's attorneys' fees, except as 8 9 authorized in this chapter; or
 - (d) Agrees to the exculpation or limitation of any liability of the landlord arising under law or to indemnify the landlord for that liability or the costs connected therewith; or
 - (e) And landlord have agreed to a particular arbitrator at the time the rental agreement is entered into; or
 - (f) Agrees to pay late fees for rent that is paid within five days following its due date. - (6) A person who, without the permission of the owner and without having color of title thereto, enters upon land of another and who fails or refuses to remove therefrom after three days' notice, in writing and served upon him or her in the manner provided in RCW 59.12.040. Such person may also be subject to the criminal provisions of chapter 9A.52 RCW; or
