What is the Medical Marijuana Program

Compliant Product

- Three categories (General Use, High THC and High CBD)
- Only cardholders may purchase High THC products
- Requires testing for prohibited pesticides and heavy metals

Registry

- Administered
 By the Department of Health
- Voluntary for adult patients, required for minors
- Used to confirm the validity of recognition cards during the sale process

MMJ Consultant

- - Not a healthcare provider
 - Must complete a 20-hour state approved training course
 - Create and issue recognition cards, assist with product selection, safe handling etc.

Compliant Product 2021 Updates

• 2021 JLARC Study

- Determined the tax exemptions are helping patients, should continue.
- JLARC recommended DOH and DOR clarify some ambiguity around which products are eligible.
- Ultimately JLARC, DOR and DOH worked together to clarify that tax exemptions are separate from and broader than compliant product classifications.

Coordination with LCB

 Clarifying product packaging requirements which will assist patients in selecting products that may benefit their medical condition.

Recognition Card Benefits



Authorized Patient Registered:

- May purchase 3 times the recreational limits
- May possess 6-15 plants if authorized
- May purchase high-THC products, when available
- Purchases at endorsed stores are not subject to sales tax
- Arrest protection
- May participate in a cooperative
- May purchase immature plants, clones and seeds from a licensed producer



Authorized Patient Not Registered:

- May purchase only in accordance with the laws and rules for non-patients
- Affirmative defense to criminal prosecution if they possess no more than four plants and six ounces of usable marijuana
- May possess 4 plants

MMJ Registry – A Word on Security

- 2SSB 5052 (2015) required that the registry be contracted out rather than hosted by DOH.
- Information in the database is exempt from public disclosure, inspection, or copying.
- 2SSB 5052 (2015) required consultation with a cybersecurity company during implementation to ensure system security and integrity.

Medical Marijuana Consultant 2021 Updates


• Emergency rule continues to allow MMJ consultants to obtain/renew certification without taking first aid/CPR course in person (i.e., online completion is acceptable)

• Chapter 246-72 MMJ Consultant rulemaking in progress

 Update training requirements to reflect evolving industry standards


Patient Statistics 2021

- Adults- Average age is 52, the most common authorization being intractable pain
 - Average age has increased from 50 to 52 since 2019



 Minors- Average age remains 12, the most common authorization being epilepsy
