AN ACT Relating to exempting the state of Washington from 1 2 daylight saving time by implementing year-round Pacific standard time; amending RCW 1.20.050 and 35A.21.190; amending 2019 c 297 s 4 3 4 (uncodified); creating a new section; repealing RCW 1.20.051; providing an effective date; providing a contingent effective date; 5 6 and providing a contingent expiration date.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

Sec. 1. The legislature finds that the state of 8 NEW SECTION. Washington would benefit from the consistency and predictability of 9 10 observing Pacific standard time throughout the calendar 11 Research has shown that changing to and from daylight saving time 12 twice per year has negative impacts on public health, 13 traffic accidents and crime, disrupts agriculture scheduling, and hinders economic growth. Scientific studies have connected a number 14 15 of health consequences with the act of switching between standard 16 time and daylight saving time, including greater risks of heart 17 attacks, more frequent workplace injuries, and increased suicide rates in the days immediately after the switch. The legislature 18 passed Substitute House Bill No. 1196 in 2019 authorizing the state 19 20 to observe daylight saving time year-round if authorized by the United States congress. However, congress has not amended federal law 21

- 1 to authorize states to observe daylight saving time year-round.
- 2 Therefore, the legislature intends to exercise the rights granted
- 3 under the uniform time act, 15 U.S.C. Sec. 260a(a), and exempt the
- 4 state of Washington from daylight saving time and remain standard
- 5 time year-round.

- 6 **Sec. 2.** RCW 1.20.050 and 1953 c 2 s 1 are each amended to read 7 as follows:
- 8 (1) The standard time for the state of Washington is the zone
 9 designated by the United States department of transportation for the
 10 state of Washington under the uniform time act, 15 U.S.C. Secs. 261
 11 and 263, as determined by reference to coordinated universal time.
- (2) Notwithstanding any other provision of law to the contrary by
 the United States government relating to adoption of daylight saving
 time by all of the states, the state of Washington elects to reject
 such time and elects to continue in force the terms of subsection (1)
 of this section, relating to standard time in Washington.
 - (3) No county, city, or other political subdivision of this state shall adopt any provision for the observance of daylight saving time, or any time other than standard((, except pursuant to a gubernatorial proclamation declaring an emergency during a period of national war and authorizing such adoption, or)) unless ((other than standard)) another time is established on a national basis((: PROVIDED, That this)). This section shall not apply to orders made by federal authorities in a local area entirely under federal control.
- 25 (4) This section shall not be construed to affect the standard time established by United States law governing the movements of common carriers engaged in interstate commerce or the time for performance of an act by an officer or department of the United States, as established by a statute, lawful order, rule, or regulation of the United States or an agency thereof.
