CANNABIS ENFORCEMENT RESPONSE TEAM

Received funding in 2018 to establish a team of detectives focused on investigating the illegal production, distribution, and diversion of cannabis from the legal market.

Cannabis Enforcement Response Team (CERT) was created.

OUR MISSION is to eradicate illegal cannabis drug trafficking organizations.



ORGANIZATIONAL STRUCTURE



WHAT WE DO

- Conduct investigations
- Receive complaint and/or intelligence from varying sources
- Conduct surveillance/gather intelligence
- Identify drug trafficking organizations (DTO) properties, locations, and involved persons and vehicles
- Organize resources for search warrant operations
- Serve search warrants, collect evidence, and refer charges




INVESTIGATIVE APPROACH

- Odor confirmation
- Power records
- Identify residential owner
- Vehicles involved
 - Use of GPS trackers
 - Use of pole cameras
- Potential employment/income information
- Deconfliction with LCB to confirm unlicensed
- Other associated locations



HOW ARE WE SUPPORTED



Information is provided to Intelligence Analysts

Represent and comprehend relationships among individuals, properties, vehicles, and businesses

Identify key nodes to target to disrupt/dismantle illegal activities

Decipher organizational hierarchies

Uncover patterns

Dynamically update network picture as investigation's progress

SEARCH WARRANT OPERATIONS

- Often involves multiples locations
- Pattern of life intelligence is utilized to guide when to serve warrants
- Multi-agency operations and require significant resources and logistics
- Growers (aka tenders) have very little information about who runs or controls the grow
- Chinese and Spanish interpreters are often used to interview suspects







INDOOR GROW REVENUE/OUTPUTS

Average indoor grow houses:

• 1,000 plants

One average plant will produce:

• 1/3 pound of bud

One pound of black-market wholesale bud sees:

• \$4,000 (street value: 3-4 times wholesale)

Most growers run 3-4 stages

One average grow house will produce:

• 350 pounds each month

Dangers associated with enforcement:

- Electrical hazards
- Chemical hazards
- Structural integrity
- Closed-air environment
- Mold exposure

Relationships established with DOE, PUD, HUD, and many others



VISION FOR THE FUTURE

- More narrowly focused on finances
 - Currently training an analyst in the field of forensic accounting
- More in-depth investigations to trace illicit funds back to a DTO leader
 - Plant eradication remains a function
 - Criminality behind cannabis manufacturing/ production is highly complex
- Innovating how CERT eradicates to minimize hazard exposures without sacrificing dismantlement and disruption to these criminal organizations
