
















#### Motorcyclist Fatalities in Washington, 2014-2023\* (2023 is preliminary)





## **DRIVER EDUCATION & CRASH RISK**



**Notes:** Only young drivers who were likely first licensed in Washington State prior to the date of the crash are included. Crash rates are calculated using average annual crashes and licensed driver counts for 2020 through 2022. This chart includes all crashes (including non-injury, injury, unknown injury, and fatal crashes).



## HIGH-VISIBILITY ENFORCEMENT GOAL: PREVENT/DETER HIGH-RISK BEHAVIOR

- Dedicated campaigns focused on one or more high-risk driving behaviors: impairment, speeding, distraction, and/or lack of seatbelt use.
- Time limited: one day, one weekend, one week, one month.
- Law enforcement highly visible, supported by public information through press releases to traditional media, social media posts, PSAs, etc.
- Often multi-jurisdictional; may be local, regional, or statewide.
- May be timed with national campaigns, local events, or in response to trends in crashes or violations observed.





## **IMPAIRED DRIVING**





FEW REPORT ALCOHOL **IMPAIRED** DRIVING. ALMOST **EVERYONE AGREES IT IS** DANGEROUS.

2023-2024 Statewide Traffic Safety Survey Results (N=21,523)	Percent of respondents
Report driving under the influence of alcohol: Last 12 months	5.3%
Percent who believe it is dangerous to drive within an hour of consuming 2+ drinks of alcohol.	98%
Support for enforcement of alcohol- impaired DUI laws.	84%




**FEW REPORT** CANNABIS **IMPAIRED** DRIVING. ALMOST **EVERYONE AGREES IT IS** DANGEROUS.

2023-2024 Statewide Traffic Safety Survey Results (N=21,523)	Percent of respondents
Report driving under the influence of cannabis: Last 12 months.	5.2%
Believe that it is dangerous to drive within one hour of consuming cannabis.	97%
Support for enforcement of cannabis-impaired driving laws.	78%

## WASHINGTON STATE FAIR: PIERCE COUNTY TASKFORCE EMPHASIS PATROLS

Organized by Pierce County Law Enforcement Liaison and Taskforce Coordinator, Sgt. David Obermiller, Puyallup PD

- 806 Total Contacts, 672 Total Citations, 252 Total Warnings
- 90 DUI Arrests by Taskforce Participants
- 52% impaired by alcohol, 42% other drugs, 6% alcohol and drugs

Also:

- 308 speeding citations
- 48 using electronic device citations
- 31 seatbelt citations

# SPEED RESPONSES: STATEWIDE SURVEY, 2023-2024 (N= 21,523)

#### **Self Report: Behavior**

Drove 10+ mph over posted speeds within last 30 days?	
Usually/Always	13%
Sometimes/Seldom	58%
Never	29%

#### **Attitudes: Risk**

How dangerous to drive 10+ mph over limit?	
Very/extremely	38%
Slightly/moderately	58%
Not at all	4%

#### 63% of respondents support speed enforcement




## ONE LAST STOP HVE, IN HONOR OF WSP TROOPER GADD, BADGE #927

September 27-28, 2024, HVE involving law enforcement agencies across Washington, Oregon, and Idaho.

EXAMPLE -- Log notes from Sgt. Tyson Luce, Auburn Police Department:


- 22 Speed infractions (out of 36 total infractions).
- Fastest: 67 in a 35 mph zone.
- Average Speed: 20.1 mph over the speed limit
- 2 Cellphone Distraction.
- 1 Driving with License Suspended (DWLS), 3<sup>rd</sup> degree.
- 1 Ignition Interlock Device violation arrest.

# DISTRACTION RESPONSES: STATEWIDE SURVEY, 2023-2024 (N= 21,523)

#### Self Report: Behavior

Driven within the last 12 months while manually interacting with cell phone	
Usually/Always	4%
Sometimes/Seldom	35%
Never	71%

#### Attitudes: Risk

How dangerous to drive while manually interacting with cell phone?	
Very/extremely	85%
Slightly/moderately	14%
Not at all	<1%

Most (78%) respondents support enforcement of driving while using cell phone.
