- 1 AN ACT Relating to organic products; amending RCW 15.86.010,
- 2 15.86.020, 15.86.030, 15.86.031, 15.86.050, 15.86.060, and 15.86.070;
- 3 reenacting and amending RCW 42.17.310; and adding new sections to
- 4 chapter 15.86 RCW.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 15.86.010 and 1985 c 247 s 1 are each amended to read
- 7 as follows:
- 8 The legislature recognizes a public benefit in establishing
- 9 standards for ((food)) agricultural products marketed and labeled using
- 10 the term "organic" or a derivative of the term "organic." Such
- 11 standards shall also facilitate the development of out-of-state markets
- 12 for Washington food grown by organic methods.

- 1 Sec. 2. RCW 15.86.020 and 1989 c 354 s 32 are each amended to read
- 2 as follows:
- 3 Unless the context clearly requires otherwise, the definitions in
- 4 this section apply throughout this chapter.
- 5 (1) "Director" means the director of the department of agriculture
- 6 or the director's designee.
- 7 (2) "Organic food" means any ((food)) agricultural product,
- 8 including meat, dairy, and beverage, that is marketed using the term
- 9 organic or any derivative of organic, other than the phrase "transition
- 10 to organic food, "in its labeling or advertising.
- 11 (3) "Producer" means any person or organization who or which
- 12 $((\frac{a}{a}))$ grows, raises, or produces $(\frac{a \text{ food}}{a})$ an agricultural
- 13 product((; and (b) sells the food product as, or offers it for sale as,
- 14 an organic food)).
- 15 (4) "Vendor" means anyone who sells or arranges the sale of organic
- 16 food to the consumer or another vendor.
- 17 (5) "Transition to organic food" means any food product that
- 18 satisfies all of the requirements of organic food except the time
- 19 requirements and satisfied all of the requirements of RCW 15.86.031.
- 20 (6) "Organic certifying agent" means any third-party certification
- 21 organization that is recognized by the director by rule as being one
- 22 which imposes, for certification, standards consistent with this
- 23 <u>chapter.</u>
- 24 (7) "Processor" means any person engaged in the canning, freezing,
- 25 drying, dehydrating, cooking, pressing, powdering, packaging, baking,
- 26 heating, mixing, grinding, churning, separating, extracting, cutting,
- 27 <u>fermenting</u>, eviscerating, preserving, jarring, or otherwise processing
- 28 <u>organic food.</u>

- 1 (8) "Person" means any natural person, firm, partnership, exchange,
- 2 association, trustee, receiver, corporation, and any member, officer,
- 3 or employee thereof or assignee for the benefit of creditors.
- 4 (9) "Department" means the state department of agriculture.
- 5 (10) "Represent" means to hold out as or to advertise.
- 6 (11) "Sale" means selling, offering for sale, holding for sale,
- 7 preparing for sale, trading, bartering, offering a gift as an
- 8 <u>inducement for sale of, and advertising for sale in any media.</u>
- 9 **Sec. 3.** RCW 15.86.030 and 1989 c 354 s 30 are each amended to read 10 as follows:
- 11 To be labeled, sold, or represented as an organic food, a product
- 12 shall be produced with only those materials and practices approved
- 13 under RCW 15.86.060. A producer, processor, or a vendor shall not
- 14 represent, sell, or offer for sale any food product with the
- 15 representation that the product is an organic food if the producer $_{\perp}$
- 16 processor, or vendor knows, or in the case of a producer or processor
- 17 has reason to know, that the food has been grown, raised, or produced
- 18 with the use of any ((of the following substances: (1) Fertilizers but
- 19 excluding manures and other natural fertilizers; (2) any of the
- 20 following when manufactured by man: Pesticides, hormones, antibiotics,
- 21 or growth stimulants but excluding Bacillus thuringensis and other
- 22 natural pesticides; (3) arsenicals; or (4) similar substances))
- 23 prohibited materials listed by the director under RCW 15.86.060. ((A))
- 24 Organic animal products shall be considered as "grown, raised, or
- 25 produced" with a substance listed by the director under RCW 15.86.060
- 26 if the substance has been applied to the plants, soil, water, or
- 27 <u>animal</u>, on or in which the organic animal product is being produced
- 28 during such time frame as specified by the director by rule. Other
- 29 food products shall be considered as "grown, raised, or produced" with

- 1 a substance ((specified in this section or)) listed by the director
- 2 under RCW 15.86.060 if the substance is applied to the plants, soil, or
- 3 water, on or in which the food product is being produced at any time
- 4 ((before)) from three years before harvest to the final sale to retail
- 5 purchasers.
- 6 **Sec. 4.** RCW 15.86.031 and 1989 c 354 s 31 are each amended to read
- 7 as follows:
- 8 (1) ((Beginning January 1, 1991, it shall be unlawful to sell or
- 9 offer for sale as organic food, products that have been grown, raised,
- 10 or produced if harvest of the food product occurs within two years of
- 11 the most recent use of any prohibited pesticide, herbicide, or
- 12 fungicide and two years after the most recent use of a prohibited
- 13 fertilizer.
- 14 (2) Beginning January 1, 1992,)) Except as provided in section 9 of
- 15 this act, it shall be unlawful to represent, sell, or offer for sale as
- 16 organic food, products that have been grown, raised, or produced if
- 17 harvest of the food product occurs within three years of the most
- 18 recent use of any prohibited ((pesticide, herbicide, or fungicide and
- 19 two years after the most recent use of a prohibited fertilizer))
- 20 substance as listed by the director under RCW 15.86.060.
- 21 (((3) Beginning January 1, 1990,)) (2) Food products may be sold as
- 22 "transition to organic food" if they have had no applications of
- 23 prohibited substances within one year before harvest of the food crop.
- 24 ((The products must specify first or second-year transition on their
- 25 labels.
- (4+)) (3) No out-of-state products shall be labeled or sold as
- 27 organic without having first received an organic certification ((in the
- 28 state of origin)) from an organic certifying agent meeting all
- 29 requirements established under this chapter.

- 1 Sec. 5. RCW 15.86.050 and 1985 c 247 s 5 are each amended to read
- 2 as follows:
- 3 A producer shall not sell to a vendor <u>or processor</u> any food product
- 4 which the producer represents as an organic food unless before the sale
- 5 the producer provides the vendor or processor with an organic food
- 6 certificate or a sworn statement that the producer has grown, raised,
- 7 or produced the product in conformance with ((RCW 15.86.030)) this
- 8 <u>chapter</u>.
- 9 <u>NEW SECTION.</u> **Sec. 6.** LABELING OF ORGANIC FOOD PRODUCTS. Organic
- 10 food products handled, processed, sold, offered for sale, advertised,
- 11 or represented shall be labeled as organic on all invoices, boxes,
- 12 bins, and other packaging and documentation associated with the
- 13 product. All organic food products sold or processed in the state
- 14 shall have recordkeeping sufficient to track the product to the farm
- 15 where the food was grown, raised, or produced.
- 16 **Sec. 7.** RCW 15.86.060 and 1985 c 247 s 6 are each amended to read
- 17 as follows:
- 18 (1) The director shall adopt such rules and regulations, in
- 19 conformity with chapter 34.05 RCW, as the director believes are
- 20 appropriate for the proper administration of this chapter.
- 21 (2) ((Whenever the director believes it appropriate to protect the
- 22 interest of consumers of organic foods, the director shall add to the
- 23 list of substances that may not be included in organic foods under this
- 24 chapter.)) The director shall establish a list of approved substances
- 25 that may be used in the production, processing, and handling of organic
- 26 <u>food</u>. This list shall:
- 27 (a) Approve the use of natural substances except for specific
- 28 <u>natural substances that may not be used in the production and handling</u>

- 1 of agricultural products labeled as organic because these substances
- 2 would be harmful to human health or the environment and are
- 3 inconsistent with organic farming principles;
- 4 (b) Prohibit the use of synthetic substances except for specific
- 5 synthetic substances that may be used in the production and handling of
- 6 agricultural products labeled as organic because these substances:
- 7 (i) Would not be harmful to human health or the environment;
- 8 (ii) Are necessary to the production or handling of the
- 9 agricultural products;
- 10 (iii) Are consistent with organic farming principles; and
- 11 <u>(iv) Are used in the production of agricultural products and</u>
- 12 contain active synthetic ingredients in the following categories:
- 13 Copper and sulfur compounds; toxins derived from bacteria; pheromones;
- 14 soaps; horticultural oils; vitamins and minerals; livestock
- 15 parasiticides and medicines; and production aids including netting,
- 16 tree wraps and seals, insect traps, sticky barriers, row covers, and
- 17 equipment cleansers; or
- 18 (v) Are used in production and contain synthetic inert ingredients.
- 19 (3) The director shall issue orders to producers, processors, or
- 20 vendors whom ((it)) he or she finds are violating any provision of this
- 21 chapter, or rules or regulations adopted under this chapter, to cease
- 22 their violations and desist from future violations. Whenever the
- 23 director finds that a producer, processor, or vendor has committed a
- 24 violation, the director shall impose on and collect from the violator
- 25 a civil fine not exceeding the total of the following amounts: (a) The
- 26 state's estimated costs of investigating and taking appropriate
- 27 administrative and enforcement actions in respect to the violation; and
- 28 (b) one thousand dollars.
- 29 (4) The director may deny, suspend, or revoke a certification
- 30 provided for in this chapter if he or she determines that an applicant

- 1 or certified person has violated this chapter or rules adopted under
- 2 <u>it.</u>
- 3 NEW SECTION. Sec. 8. MANDATORY CERTIFICATION AND REGISTRATION.
- 4 (1) It is unlawful for any person to sell, offer for sale, or process
- 5 any agricultural product within this state with an organic label unless
- 6 that person is certified under this chapter by the department or an
- 7 official organic certifying agent.
- 8 (2) Subsection (1) of this section shall not apply to (a) final
- 9 retailers of organic food that do not process organic food products or
- 10 (b) producers who sell no more than five thousand dollars annually in
- 11 value of agricultural products directly to consumers.
- 12 <u>NEW SECTION.</u> **Sec. 9.** TOLERANCE LEVELS FOR ORGANIC FOOD. (1) An
- 13 agricultural product that is being grown, raised, or produced under the
- 14 provisions of this chapter may not be labeled, sold, or represented as
- 15 organic if during the course of the crop year it is subjected to drift
- 16 of materials not on the approved substances list as established by the
- 17 director under RCW 15.86.060.
- 18 An agricultural product that is being grown, raised, or produced
- 19 under the provisions of this chapter and is subjected to drift of
- 20 prohibited materials may be labeled or sold as organic in the
- 21 subsequent crop year as long as the tolerance levels of prohibited
- 22 materials do not exceed the levels stated in subsection (2) of this
- 23 section.
- 24 (2) An agricultural product that is being grown, raised, or
- 25 produced under the provisions of this chapter and contains residues of
- 26 materials not on the approved substances list established by the
- 27 director under RCW 15.86.060 in excess of five percent of the United
- 28 States environmental protection agency tolerance level or, where there

- 1 is no tolerance level, five percent of the United States food and drug
- 2 administration action level may not be labeled, sold, or represented as
- 3 organic.
- 4 Sec. 10. RCW 15.86.070 and 1989 c 354 s 34 are each amended to
- 5 read as follows:
- 6 The director may adopt rules establishing a certification program
- 7 for producers ((and)), processors, and vendors of organic or transition
- 8 to organic food. The rules may govern, but are not limited to
- 9 governing: The number and scheduling of on-site visits, both announced
- 10 and unannounced, by certification personnel; recordkeeping
- 11 requirements; and the submission of product samples for chemical
- 12 analysis. The rules shall include a fee schedule that will provide for
- 13 the recovery of the full cost of the ((inspection)) organic food
- 14 program. Fees collected under this section shall be deposited in an
- 15 account within the agricultural local fund and the revenue from such
- 16 fees shall be used solely for carrying out the provisions of this
- 17 section, and no appropriation is required for disbursement from the
- 18 fund. The director may employ such personnel as are necessary to carry
- 19 out the provisions of this section.
- 20 <u>NEW SECTION.</u> **Sec. 11.** (1) Except as provided in subsection (2)
- 21 of this section, the department shall keep confidential any business
- 22 related information obtained under this chapter concerning an entity
- 23 certified under this chapter or an applicant for such certification and
- 24 such information shall be exempt from public inspection and copying
- 25 under chapter 42.17 RCW.
- 26 (2) Applications for certification under this chapter and
- 27 laboratory analyses pertaining to that certification shall be available
- 28 for public inspection and copying.

- 1 Sec. 12. RCW 42.17.310 and 1991 c 301 s 13, 1991 c 87 s 13, and
- 2 1991 c 23 s 10 are each reenacted and amended to read as follows:
- 3 (1) The following are exempt from public inspection and copying:
- 4 (a) Personal information in any files maintained for students in
- 5 public schools, patients or clients of public institutions or public
- 6 health agencies, or welfare recipients.
- 7 (b) Personal information in files maintained for employees,
- 8 appointees, or elected officials of any public agency to the extent
- 9 that disclosure would violate their right to privacy.
- 10 (c) Information required of any taxpayer in connection with the
- 11 assessment or collection of any tax if the disclosure of the
- 12 information to other persons would (i) be prohibited to such persons by
- 13 RCW 82.32.330 or (ii) violate the taxpayer's right to privacy or result
- 14 in unfair competitive disadvantage to the taxpayer.
- 15 (d) Specific intelligence information and specific investigative
- 16 records compiled by investigative, law enforcement, and penology
- 17 agencies, and state agencies vested with the responsibility to
- 18 discipline members of any profession, the nondisclosure of which is
- 19 essential to effective law enforcement or for the protection of any
- 20 person's right to privacy.
- 21 (e) Information revealing the identity of persons who file
- 22 complaints with investigative, law enforcement, or penology agencies,
- 23 other than the public disclosure commission, if disclosure would
- 24 endanger any person's life, physical safety, or property. If at the
- 25 time the complaint is filed the complainant indicates a desire for
- 26 disclosure or nondisclosure, such desire shall govern. However, all
- 27 complaints filed with the public disclosure commission about any
- 28 elected official or candidate for public office must be made in writing
- 29 and signed by the complainant under oath.

- 1 (f) Test questions, scoring keys, and other examination data used
- 2 to administer a license, employment, or academic examination.
- 3 (g) Except as provided by chapter 8.26 RCW, the contents of real
- 4 estate appraisals, made for or by any agency relative to the
- 5 acquisition or sale of property, until the project or prospective sale
- 6 is abandoned or until such time as all of the property has been
- 7 acquired or the property to which the sale appraisal relates is sold,
- 8 but in no event shall disclosure be denied for more than three years
- 9 after the appraisal.
- 10 (h) Valuable formulae, designs, drawings, and research data
- 11 obtained by any agency within five years of the request for disclosure
- 12 when disclosure would produce private gain and public loss.
- 13 (i) Preliminary drafts, notes, recommendations, and intra-agency
- 14 memorandums in which opinions are expressed or policies formulated or
- 15 recommended except that a specific record shall not be exempt when
- 16 publicly cited by an agency in connection with any agency action.
- 17 (j) Records which are relevant to a controversy to which an agency
- 18 is a party but which records would not be available to another party
- 19 under the rules of pretrial discovery for causes pending in the
- 20 superior courts.
- 21 (k) Records, maps, or other information identifying the location of
- 22 archaeological sites in order to avoid the looting or depredation of
- 23 such sites.
- 24 (1) Any library record, the primary purpose of which is to maintain
- 25 control of library materials, or to gain access to information, which
- 26 discloses or could be used to disclose the identity of a library user.
- 27 (m) Financial information supplied by or on behalf of a person,
- 28 firm, or corporation for the purpose of qualifying to submit a bid or
- 29 proposal for (a) a ferry system construction or repair contract as

- 1 required by RCW 47.60.680 through 47.60.750 or (b) highway construction
- 2 or improvement as required by RCW 47.28.070.
- 3 (n) Railroad company contracts filed with the utilities and
- 4 transportation commission under RCW 81.34.070, except that the
- 5 summaries of the contracts are open to public inspection and copying as
- 6 otherwise provided by this chapter.
- 7 (o) Financial and commercial information and records supplied by
- 8 private persons pertaining to export services provided pursuant to
- 9 chapter 43.163 RCW and chapter 53.31 RCW.
- 10 (p) Financial disclosures filed by private vocational schools under
- 11 chapter 28C.10 RCW.
- 12 (q) Records filed with the utilities and transportation commission
- 13 or attorney general under RCW 80.04.095 that a court has determined are
- 14 confidential under RCW 80.04.095.
- 15 (r) Financial and commercial information and records supplied by
- 16 businesses during application for loans or program services provided by
- 17 chapter 43.163 RCW and chapters 43.31, 43.63A, and 43.168 RCW.
- 18 (s) Membership lists or lists of members or owners of interests of
- 19 units in timeshare projects, subdivisions, camping resorts,
- 20 condominiums, land developments, or common-interest communities
- 21 affiliated with such projects, regulated by the department of
- 22 licensing, in the files or possession of the department.
- 23 (t) All applications for public employment, including the names of
- 24 applicants, resumes, and other related materials submitted with respect
- 25 to an applicant.
- 26 (u) The residential addresses and residential telephone numbers of
- 27 employees or volunteers of a public agency which are held by the agency
- 28 in personnel records, employment or volunteer rosters, or mailing lists
- 29 of employees or volunteers.

- 1 (v) The residential addresses and residential telephone numbers of
- 2 the customers of a public utility contained in the records or lists
- 3 held by the public utility of which they are customers.
- 4 (w) Information obtained by the board of pharmacy as provided in
- 5 RCW 69.45.090.
- 6 (x) Information obtained by the board of pharmacy or the department
- 7 of health and its representatives as provided in RCW 69.41.044,
- 8 69.41.280, and 18.64.420.
- 9 (y) Financial information, business plans, examination reports, and
- 10 any information produced or obtained in evaluating or examining a
- 11 business and industrial development corporation organized or seeking
- 12 certification under chapter 31.24 RCW.
- 13 (z) Financial and commercial information supplied to the state
- 14 investment board by any person when the information relates to the
- 15 investment of public trust or retirement funds and when disclosure
- 16 would result in loss to such funds or in private loss to the providers
- 17 of this information.
- 18 (aa) Financial and valuable trade information under RCW 51.36.120.
- 19 (bb) Client records maintained by an agency that is a domestic
- 20 violence program as defined in RCW 70.123.020 or a rape crisis center
- 21 as defined in RCW 70.125.030.
- 22 (cc) Business related information protected from public inspection
- 23 and copying under section 11 of this act.
- 24 (2) Except for information described in subsection (1)(c)(i) of
- 25 this section and confidential income data exempted from public
- 26 inspection pursuant to RCW 84.40.020, the exemptions of this section
- 27 are inapplicable to the extent that information, the disclosure of
- 28 which would violate personal privacy or vital governmental interests,
- 29 can be deleted from the specific records sought. No exemption may be

- 1 construed to permit the nondisclosure of statistical information not
- 2 descriptive of any readily identifiable person or persons.
- 3 (3) Inspection or copying of any specific records exempt under the
- 4 provisions of this section may be permitted if the superior court in
- 5 the county in which the record is maintained finds, after a hearing
- 6 with notice thereof to every person in interest and the agency, that
- 7 the exemption of such records is clearly unnecessary to protect any
- 8 individual's right of privacy or any vital governmental function.
- 9 (4) Agency responses refusing, in whole or in part, inspection of
- 10 any public record shall include a statement of the specific exemption
- 11 authorizing the withholding of the record (or part) and a brief
- 12 explanation of how the exemption applies to the record withheld.
- 13 <u>NEW SECTION.</u> **Sec. 13.** CAPTIONS NOT LAW. Captions as used in
- 14 sections 6, 8, 9, and 13 of this act do not constitute part of the law.
- 15 <u>NEW SECTION.</u> **Sec. 14.** Sections 6, 8, 9, 11, and 13 of this act
- 16 are each added to chapter 15.86 RCW.
